RESOLUTION

WHEREAS, The son of Joseph Ralph DeWitt III and Norma DeWitt, 4 5 Ralph DeWitt was born in Houston in 1952; he spent some of his youth in San Antonio and Chicago before graduating from Monterrey High 6 7 School in Lubbock; while studying business management at Texas Tech University, he paid for his studies by working in a grocery store, 8 9 driving a cab, delivering newspapers, and working as a nightclub DJ; he also honed his entrepreneurial skills by buying and selling 10 used cars, venturing into concert promotion, and investing in 11 12 residential and commercial properties; and

WHEREAS, Mr. DeWitt was also an avid record collector, and in 14 1980, he realized his dream of turning his hobby into a business; he 15 opened Ralph's Records in a small space on University Avenue, and 16 within two years, he was able to expand; for a time, he also ran 17 shops in Oklahoma City and Amarillo, as well as a second location in 18 Lubbock; the store has operated at its current 82nd Street address 19 since 1991; and

20 WHEREAS, Fostering a friendly, laid-back atmosphere that 21 customers loved, Mr. DeWitt always hired musicians and fellow music 22 fans and encouraged them to share their knowledge, ideas, and 23 opinions; the industry changed dramatically over the years, but he 24 was able to adapt, adding such items as CDs, DVDs, and video games;

1 all the while, he retained his allegiance to vinyl records, and he 2 was ready to take full advantage of the revival of the format in the 3 current decade; through the years, he has also been a steadfast 4 supporter of live music in the city; and

5 WHEREAS, Devoted to his family, Mr. DeWitt has benefited in 6 all his endeavors from the encouragement of his wife, Polly, his 7 children, Allison and Joey, and his mother, Norma, as well as his 8 four siblings; and

9 WHEREAS, Ralph DeWitt has set a sterling example of 10 entrepreneurship while making vital contributions to the Lubbock 11 music scene, and as he embarks on the next exciting chapter of his 12 life, he may reflect with justifiable pride on his accomplishments; 13 now, therefore, be it
