WHEREAS, After his graduation, Mr. Foster set his sights on a 13 14 career as a commercial airline pilot; while pursuing undergraduate studies at North Central Texas College, he obtained additional 15 flight certifications at ATP Flight School in Phoenix and 16 Scottsdale, Arizona; he subsequently worked at US Aviation as a 17 test pilot, before being hired by SkyWest Airlines in Denver, where 18 he flew regional jets as a first officer; he had recently completed 19 the National Homeland Security Federal Flight Deck Officer 20 21 certification program, during which he received a medal for the Top Marksmanship Award; and 22

23 WHEREAS, While the sudden loss of such a promising young man 24 brings immeasurable sorrow to many, Tyler Foster set an example of
