

R E S O L U T I O N

1           WHEREAS, Westbury High School in Houston is holding a  
2 groundbreaking ceremony on February 16, 2017, to commemorate the  
3 start of construction on a new building addition; and

4           WHEREAS, This outstanding educational institution serves  
5 more than 2,100 students in 9th through 12th grade; under the able  
6 leadership of principal Susan Monaghan, the school offers a  
7 performing and visual arts magnet program as well as public safety  
8 career pathways, which combine rigorous academics with real-world  
9 experiences to prepare students for professions in that vital  
10 field; and

11           WHEREAS, Westbury is one of 40 schools in the Houston  
12 Independent School District to undergo renovations as part of a  
13 voter-approved 2012 bond program; the addition will include a  
14 central office area, two gyms, a weight room, a dining and kitchen  
15 area, a number of classrooms, and space for the campus Reserve  
16 Officer Training Corps; once primary construction is complete,  
17 portable buildings will be removed so that tennis courts can be  
18 erected in their place; and

19           WHEREAS, The education of young Texans is of great importance  
20 to the future of our state, and with these vital renovations to  
21 their campus, the faculty and staff of Westbury High School will be  
22 better equipped to help students reach their full potential and  
23 become engaged and productive members of the community; now,  
24 therefore, be it
