RESOLUTION

1 WHEREAS, Construction workers and members of the Build a 2 Better Texas Coalition are gathering in Austin on March 1, 2017, to promote workplace safety in the construction industry; and 3 WHEREAS, The construction industry plays a significant role 4 5 in the Texas economy, with nearly one million Texans laboring in construction and generating \$1 out of every \$20 in the economy; and 6 7 WHEREAS, Workplace safety in Texas is a serious issue; more construction workers die as a result of workplace accidents or 8 conditions in Texas than in any other state; from 2012 to 2015, 452 9 construction workers lost their lives on the job, nearly twice as 10 11 many as in the state with the next highest number of deaths; in 12 addition, one in every five construction workers in the state suffers an injury on the job that requires medical attention; and 13 14 WHEREAS, Low wages and legal violations like wage theft and payroll fraud are common, with 41 percent of the workforce 15 misclassified as independent contractors and one out of five 16 workers falling victim to wage theft, further imperiling the 17 economic stability of working families; and 18 WHEREAS, Whenever employers in the industry fail to abide by 19 20 the law, they decrease the ability of responsible businesses to 21 compete, put the physical safety of their workers at risk, and force taxpayers to pick up costs resulting from their illegal practices; 22 23 the Build a Better Texas Coalition is a group of businesses, 24 community organizations, faith-based groups, and individuals who

- 1 seek to foster workplace safety and to level the playing field for
- 2 responsible businesses; and
- 3 WHEREAS, Components of a proactive industry approach to
- 4 worker safety include providing a safe workplace, adequate safety
- 5 training and rest breaks, and workers' compensation insurance,
- 6 which ensures that both workers and employers are protected in the
- 7 event of a workplace accident; and
- 8 WHEREAS, A strong and sustainable construction industry is
- 9 essential to the economic prosperity of the Lone Star State, and
- 10 such an industry is fostered by safe workplace practices and fair
- 11 pay; now, therefore, be it
- RESOLVED, That the House of Representatives of the 85th Texas
- 13 Legislature hereby recognize March 1, 2017, as the Day of the Fallen
- 14 in memory of the thousands of Texans who have died in
- 15 construction-related accidents and call on leaders in the
- 16 construction industry to uphold the highest standards of workplace
- 17 safety; and, be it further
- 18 RESOLVED, That an official copy of this resolution be
- 19 prepared for the Build a Better Texas Coalition to commemorate the
- 20 Day of the Fallen.
