## RESOLUTION

1 WHEREAS, Members of the Sheriffs' Association of Texas are 2 gathering in Austin on February 28, 2017, to participate in 3 Sheriffs' Association of Texas Day at the Capitol; and WHEREAS, The Texas Constitution created the office of sheriff 4 in each county of the state; legislation requires that a sheriff 5 conserve peace and enforce the criminal laws of the state; 6 moreover, the sheriff is responsible for the county jail, bail 7 bonds, civil process, and the security of the courts, and in some 8 9 smaller counties, the sheriff may also act as the tax collector; and WHEREAS, The first meeting of the Sheriffs' Association of 10 11 Texas took place on August 14, 1874, making this group one of the 12 oldest law enforcement organizations in the nation; association members adopted their preamble calling for sheriffs to assist one 13 14 another in the execution of laws, in the discharge of their duties against criminals, and in the protection of the citizens in their 15 16 respective counties and throughout the state; the group has continued to follow the dictates of this mission to this day; and 17 18 WHEREAS, Sheriffs in our state's 254 counties are elected to four-year terms; each sheriff is a member of the Sheriffs' 19 20 Association of Texas, and thousands of other Texans are active and 21 associate members of the group; and WHEREAS, The men and women of the Sheriffs' Association of 22 23 Texas are helping to make the Lone Star State an even safer place,
