## RESOLUTION

1 WHEREAS, Dr. Suzanne J. Nelson, superintendent of the 2 Tuloso-Midway Independent School District, has been named the 2016 3 Superintendent of the Year for Education Service Center Region 2; 4 and

5 WHEREAS, Since 1984, the Texas Association of School Boards 6 has sponsored this annual award to recognize local school district 7 superintendents for their leadership skills, commitment to public 8 involvement in education, and dedication to improving educational 9 quality, student performance, and employee relations; and

WHEREAS, A native of Colorado Springs, Colorado, Dr. Nelson 10 11 began her career as a teacher in Edmond, Oklahoma; she joined the 12 Tuloso-Midway ISD as director of elementary and secondary education in 1984, and two years later, she became district superintendent; 13 14 after 12 years' outstanding service in that post, she retired in 1998, but 1999 she accepted an appointment as 15 in school 16 superintendent in Eagle Pass; subsequent attempts at a life of short-lived: she returned to 17 leisure were equally lead Tuloso-Midway again in 2005, took up the reins of George West ISD in 18 2007, and embarked on her third tenure as superintendent of 19 20 Tuloso-Midway in 2010; and

21 WHEREAS, Since returning to the district six years ago, Dr. 22 Nelson has been instrumental in securing the passage of several 23 measures, including a \$36 million bond package, that have enabled 24 the construction and renovation of a number of school facilities;

her successful efforts to improve the district's financial 1 practices have resulted in top ratings from the School Financial 2 Integrity Rating System of Texas, and she has also increased the 3 diversity of her district's administrative team and professional 4 5 staff; of her many accomplishments at Tuloso-Midway over the years, she takes greatest pride in leading the transition to a year-round 6 school calendar, which the district introduced in 1994; 7 in 8 appreciation for all that she has done in behalf of TMISD, the performing arts center at Tuloso-Midway High School was named in 9 her honor in 2014; and 10

11 WHEREAS, Dr. Sue Nelson's hard work and commitment to 12 excellence have made a positive difference in the lives of 13 countless Texas students for more than 30 years, and her receipt of 14 this prestigious accolade provides a fitting opportunity to 15 recognize her outstanding contributions to the Lone Star State; 16 now, therefore, be it
