- 1 WHEREAS, Civic-minded residents of Beaumont, Orange, Port
- 2 Arthur, and other communities in Jefferson and Orange Counties are
- 3 visiting Austin March 5-7, 2017, to celebrate Golden Triangle Days
- 4 at the State Capitol; and
- 5 WHEREAS, A strategically important source of energy and
- 6 chemical manufactured products, the Golden Triangle refines about
- 7 13 percent of the nation's gasoline daily, including 60 percent of
- 8 its commercial jet fuel and the majority of its military jet fuel;
- 9 and
- 10 WHEREAS, The region is served by the Sabine Neches Waterway,
- 11 which ranks fourth in the United States for total tonnage and
- 12 supports a large percentage of the nation's petrochemical industry;
- 13 it is the country's top commercial military out-load port and the
- 14 first in crude oil imports, and on June 10, 2014, the federal
- 15 government authorized an improvement project that will deepen the
- 16 channel to 48 feet, enhancing the global competitiveness of this
- 17 key gateway; and
- 18 WHEREAS, The Golden Triangle is also linked to an extensive
- 19 rail and pipeline system; construction has been completed on a
- 20 pipeline from Oklahoma to Jefferson County, and with over \$3
- 21 billion in announced new economic development projects and another
- 22 \$20 billion under consideration, the region has become an
- 23 increasingly vital contributor to the economic prosperity of the
- 24 state; and

- 1 WHEREAS, The area's population has access to such notable
- 2 institutions of higher education as Lamar University, Lamar State
- 3 College-Orange, Lamar State College-Port Arthur, and the Lamar
- 4 Institute of Technology; moreover, a number of training programs
- 5 are available to ensure the preparedness of the workforce;
- 6 residents further benefit from unique cultural and environmental
- 7 sites, among them Shangri La Botanical Gardens and Nature Center,
- 8 Big Thicket National Preserve, and coastal habitats such as Sea Rim
- 9 State Park and the McFadden National Wildlife Refuge, which also
- 10 draw many tourists; and

- 12 Counties are working together to build a vibrant, prosperous future
