5 WHEREAS, A successful entrepreneur, Ms. Roberts pursued a 6 number of business ventures, including the trucking company that 7 she and her husband owned, Like Magic Transportation; she also 8 worked as a licensed real estate and loan officer, and she had a 9 passion for Harley-Davidson motorcycles; a woman who drew on her 10 faith for guidance and inspiration, she was a valued member of 11 St. Luke Missionary Baptist Church in Humble; and
