1           WHEREAS, A full and purposeful life drew to a close with the  
2 passing of C. Maye Neal Strange of Georgetown on January 25, 2017,  
3 at the age of 96; and

4           WHEREAS, The daughter of William and Lorena Dunlap, the  
5 former Clara Maye Dunlap was born on July 23, 1920; she grew up on  
6 her family's ranch near Ozona and graduated from Ozona High School  
7 before attending Texas State College for Women and Baylor  
8 University; following her studies, she returned to Ozona, where she  
9 worked as a reporter for the *Ozona Stockman* and the *Midland*  
10 *Reporter-Telegram*; in 1940, she wed Robert Neal, and they later  
11 built their home and ranching business on the Neal Ranch in  
12 Junction, spending 41 cherished years together until his death in  
13 1981; she remarried in 1988 and went on to enjoy eight years of  
14 marriage to Gwan Strange; and

15           WHEREAS, In addition to ranching, Mrs. Strange also operated  
16 her own women's clothing business, C. Maye's Shoppe, for more than  
17 three decades; she further shared her time and talents with the  
18 community as chair of the First State Bank of Junction board of  
19 directors and as a member of the Daedalian Study Club and the  
20 administrative board of the local First United Methodist Church;

22           WHEREAS, Although she will be deeply missed, memories of this  
23 beloved woman will be forever treasured by those who were fortunate  
24 enough to share in the richness of her life; now, therefore, be it
