- 1 WHEREAS, Grand Prairie lost an esteemed member of the
- 2 community with the passing of Bobby Kenneth Steen on February 2,
- 3 2017, at the age of 85; and
- WHEREAS, The son of Odessa and Isaac Steen, Bobby Steen was
- 5 born on November 15, 1931; he attended Dallas public schools and
- 6 later completed his GED through the Grand Prairie Independent
- 7 School District; coming of age during segregation, Mr. Steen
- 8 recognized the need for lodgings to serve African American
- 9 travelers; he was a 27-year-old with just a little construction
- 10 experience when he designed and built Steen's Motel in the Dalworth
- 11 community, which was founded by African Americans at the turn of the
- 12 previous century; over the years, he welcomed myriad guests to his
- 13 establishment, which featured a community kitchen and dining room,
- 14 and everyone from migrant workers to prominent entertainers enjoyed
- 15 his hospitality; and
- 16 WHEREAS, Mr. Steen developed such strong customer loyalty
- 17 that the motel continued to thrive even after integration enabled
- 18 African Americans to take advantage of more conveniently located
- 19 accommodations; in addition, he had guests who became long-term
- 20 residents and remained family friends after moving away; the motel
- 21 was designated a Grand Prairie Significant Landmark and received a
- 22 historic marker in 2007; and
- WHEREAS, A devoted family man, Mr. Steen shared a fulfilling
- 24 relationship of 42 years with his wife, Gale, and he took great

- 1 pride in his six children, Bobby, Isaac, Glen, Darrell, Ali, and
- 2 Keyma, as well as seven grandchildren and seven
- 3 great-grandchildren; he was a valued member of the Faith Fellowship
- 4 Baptist Church; and
- 5 WHEREAS, Bobby Steen lived a full and productive life
- 6 surrounded by those he loved, and they will forever hold him close
- 7 in their hearts; now, therefore, be it
- 8 RESOLVED, That the House of Representatives of the 85th Texas
- 9 Legislature hereby pay tribute to the memory of Bobby Kenneth Steen
- 10 and extend sincere condolences to his many relatives and friends;
- 11 and, be it further
- 12 RESOLVED, That an official copy of this resolution be
