1 WHEREAS, A life made rich through meaningful service drew to 2 a close with the passing of Gerald Dale Gaus of Lewisville on 3 February 27, 2017, at the age of 75; and

WHEREAS, The adopted son of Alvin and Laura Gaus, Dale Gaus 4 5 was born on January 14, 1942, and raised in Herscher, Illinois; he attended Concordia College and subsequently answered his nation's 6 call to duty, joining the United States Air Force and serving with 7 the Air Training Command during the Vietnam War; an electronics 8 instructor in the radio radar field, he taught cryptography to 9 members of all branches of the U.S. armed forces, and though he was 10 11 primarily stationed at Lackland Air Force Base in San Antonio, he 12 also spent time at Langley AFB in Virginia and aboard the naval nuclear submarine USS Triton; he attained the rank of sergeant 13 14 prior to his discharge from the armed forces; and

WHEREAS, After his return to civilian life, Mr. Gaus began teaching the collection and processing of seismographic data from the ocean floor to individuals involved in oil exploration, work that took him to locations across the globe; he later served as a fiber optics and satellite telecommunications instructor; and

20 WHEREAS, In his leisure time, Mr. Gaus pursued his great 21 passion for music; in addition to being a gifted pianist and 22 organist, he was a member of the Dallas-based ensemble Vocal 23 Majority for nearly four decades, during which time he won numerous 24 gold medals at international singing competitions and performed

1 with the Mormon Tabernacle Choir and at the inauguration of 2 President Ronald Reagan; he was also active in his community as a 3 congregant of the Lamb of God Lutheran Church in Flower Mound, where 4 he contributed his vocal talents to the What's the Message webcast, 5 and as chaplain for American Legion Post No. 182 in Little Elm; and

6 WHEREAS, Mr. Gaus treasured the moments he spent with his 7 family above all else; he shared more than half a century of 8 marriage with his wife, the former Beverly Bailey, and over the 9 years, the couple were blessed with a fine family that included two 10 children, Linda Asbell and Kevin Gaus, and three granddaughters, 11 Summer, Zarred, and Molly; and

12 WHEREAS, A man who never met a stranger, Dale Gaus brought joy 13 to innumerable people through his positive attitude, generosity of 14 spirit, and wonderful sense of humor; although he will be deeply 15 missed, those who were privileged to know him will continue to find 16 inspiration in their memories of his profound commitment to his 17 family, his community, and his country; now, therefore, be it

18 RESOLVED, That the House of Representatives of the 85th Texas 19 Legislature hereby pay tribute to the life of Gerald Dale Gaus and 20 extend heartfelt sympathy to his relatives and many friends; and, 21 be it further
