- 1 WHEREAS, Community leaders from Balch Springs are gathering
- 2 in Austin on March 30, 2017, to celebrate Balch Springs Day at the
- 3 State Capitol; and
- 4 WHEREAS, Located in Dallas County, the town traces its
- 5 history to the 1870s, when John Balch, who had fought for the
- 6 independence of Texas at the Battle of San Jacinto and other
- 7 engagements, settled in the area with his family; his land
- 8 contained a permanent spring that became a gathering place for
- 9 nearby residents, and the settlement that took shape over the
- 10 following decades was named for him and this important water
- 11 source; and
- 12 WHEREAS, Balch Springs is a home-rule city that was
- 13 incorporated in 1953, when approximately 3,000 people lived there;
- 14 the population rose in the decades that followed, with an
- 15 increasing number of manufacturing companies and other businesses
- 16 opening their doors; and
- 17 WHEREAS, Today, this bustling city is home to more than
- 18 25,000 people and serves as a southeastern gateway to the
- 19 Metroplex; it offers convenient access to the surrounding area as
- 20 well as to major interstate and international transportation
- 21 routes, and its location, combined with its forward-looking civic
- 22 leadership and productive workforce, has attracted numerous
- 23 companies, including a number of firms in the telecommunications
