1 WHEREAS, The members of St. Peter's Parish in Lindsay are 2 marking a milestone in their history with the celebration of the parish's 125th anniversary in 2017; and 3 WHEREAS, This venerable congregation traces its roots to the 4 5 early settlement of the Lindsay community by German Catholic colonists in 1891; in January 1892, settlers began meeting in the 6

14 WHEREAS, Disaster struck on May 31, 1917, when the church was almost totally destroyed by a tornado, with only the apse, facade, 15 16 steeple, and three altars left in its ruins; the parishioners rose to the challenge and, salvaging what remained of the old church, 17 completed the reconstruction by the fall of 1918; the church has 18 since weathered nearly a century of storms, and its pristine 19 condition today is a testament to the enormous effort that 20 parishioners have dedicated to its care and upkeep; the building 21 was added to the National Register of Historic Places in 1979; and 22

23 WHEREAS, Members of St. Peter's Church have benefited from 24 the efforts of many outstanding clergymen from the time of its

- 2 of the Reverend Philip Petta; the church oversees numerous
