

R E S O L U T I O N

1 WHEREAS, The conclusion of Phillip L. Montgomery's tenure as
2 president of the Justices of the Peace and Constables Association
3 of Texas on June 29, 2017, provides a fitting opportunity to
4 recognize his exemplary leadership of that organization; and

5 WHEREAS, Phil Montgomery has dedicated his career to public
6 service; he worked for the Texas Alcoholic Beverage Commission for
7 26 years, until his retirement in 2004, and from 2004 to 2006, he
8 held positions with the Devine Police Department and the La Salle
9 County Sheriff's Department; in 2007, he was elected as Precinct 4
10 Justice of the Peace in Medina County, and he has continued to serve
11 in that position with distinction; and

12 WHEREAS, That same year, Mr. Montgomery joined the Justices
13 of the Peace and Constables Association of Texas, and he served as
14 the association's secretary-treasurer from 2009 to 2013; his peers
15 named him JPCA Judge of the Year for 2012-2013; on June 30, 2016,
16 Mr. Montgomery took office as president of the JPCA, and in that
17 role, he has ably overseen the largest association of elected
18 officials in the Lone Star State, with more than 2,100 members; and

19 WHEREAS, Phil Montgomery's dedication, professionalism, and
20 commitment to excellence have greatly benefited the JPCA, and he
21 may indeed reflect with pride on a job well done; now, therefore, be
22 it

24 Legislature hereby commend Phillip L. Montgomery for his service as
