civic leader Roy Thomas Pitcock Sr., who passed away on March 17,
2017, at the age of 87; and

WHEREAS, The son of Louis and Medora Pitcock, Roy Pitcock was 4 5 born in Sylvester on March 20, 1929; he graduated from Graham High School and completed his bachelor's degree in geology at Texas 6 7 Christian University; on October 16, 1955, he married Jacqueline Garrison, and they became the parents of three daughters, Lindy, 8 9 Melissa, and Allison; over the years, Mr. Pitcock also knew the joy of welcoming four grandchildren, Jeffery, Ryan, Bailey, and Jordan, 10 and five great-grandchildren, Hailey, Thomas, Ben, Lily, and 11 12 Hamlin, into his treasured family; and

WHEREAS, Mr. Pitcock began his career as a well-site 13 14 geologist with his father's company, Rankin, Pitcock, and Karper; in 1957, he joined another family venture, Louis Pitcock Drilling 15 16 Company, and he became president of its successor firm, Pitcock Incorporated, in 1969, upon the death of his father; over the course 17 of more than six decades in the industry, he served in numerous 18 leadership roles, including president of the West Central Texas Oil 19 and Gas Association and director of the North Texas Oil and Gas 20 21 Association, the Independent Petroleum Association of America, the Texas Alliance of Energy Producers, and the North Texas Geological 22 23 Society; he was appointed by three governors to the Interstate Oil and Gas Compact Commission, and he received the prestigious 24

Wildcatter Award from the WCTOGA and the Distinguished Service
Award from the TAEP; in 1997, he was inducted into the TCU Hall of
Fame; and

WHEREAS, Deeply committed to his community, Mr. Pitcock served as a trustee of the Graham Independent School District, as a member of the Young County Appraisal Tax Board, and as a Graham city alderman for two terms; he also served as president of the Graham Lions Club and as a member of the boards of many organizations, among them the Graham Chamber of Commerce and the Graham Industrial Association; and
