1 WHEREAS, Family and friends will forever treasure their
2 memories of Douglas Arnold Anderle of Gainesville, who died on
3 January 31, 2016, at the age of 50; and

4 WHEREAS, Doug Anderle was born in Wichita Falls on September
5 15, 1965, to Orville and Shirley Anderle; after graduating from
6 high school in Lindsay in 1984, he studied agriculture at North
7 Central Texas College before becoming the main ranch hand at Wolf
8 Creek Ranch; in 1990, he was joined in matrimony to Brenda
9 Haverkamp, with whom he went on to share more than 25 years, and he
10 was the proud father of three children, Abby, Caleb, and Evan; and

11 WHEREAS, Mr. Anderle worked in Australia as part of an
12 exchange program before moving with his wife to Baggs, Wyoming; the
13 couple then settled in Gainesville, where they started a ranch; in
14 1997, Mr. Anderle joined the Gainesville Fire Department, and over
15 the course of his exemplary 19-year tenure with the department, he
16 worked his way up to lieutenant; in April 2010, he was named "City
17 Employee of the Month" for saving the city money by refitting
18 couplings from old fire hoses onto new ones; and

19 WHEREAS, Although the life of this loving family man and
20 dedicated firefighter ended far too soon, Doug Anderle leaves
21 behind a record of service that his loved ones can forever remember
22 with pride; now, therefore, be it
