12 hospitals to provide notary services at no cost to patients,
13 employees, and social workers; in October 2016, Ms. Jordan offered
14 her notary services pro bono to a grandmother seeking temporary
15 custody of her grandchildren, who had survived a tragic automobile
16 accident that killed their stepfather; Ms. Jordan also helped raise
17 funds in the family's behalf; and

19 community, Tracee Jordan has set an inspiring example of compassion
20 and generosity toward others, and she has earned the respect and
21 admiration of her peers and fellow citizens alike; now, therefore,
