1 WHEREAS, The death of Robert Michael Jelinek of Beaumont on 2 February 14, 2016, at the age of 72, brought a great loss to his family, his friends, and his colleagues in the construction 3 business; and 4 5 WHEREAS, Born in Dallas on September 19, 1943, Mike Jelinek was the son of Frank and Margaret Jelinek; he graduated from 6 Beaumont High School and went on to attend The University of Texas 7 at Austin and Lamar University; in 1965, after returning to 8 Beaumont, he married the love of his life, the former Lynn Sory; and 9 WHEREAS, Mr. Jelinek served his country in the U.S. Army 10 11 National Guard during the Vietnam War; he worked briefly in the 12 banking industry and then found his career path through a job in paving and material sales; in 1979, he began a lengthy assignment 13 14 with Bo-Mac Contractors, supervising the paving division and estimating state highway projects; he joined Williams Brothers 15 Construction Company in 2001, and during his last few years with the 16 company, he was supervisor of the Interstate 10 construction jobs 17 18 from Beaumont to the Louisiana state line, making sure the highway construction met state specifications; dedicated to his work, he 19 20 fulfilled his responsibilities until the day of his hospitalization 21 in November 2015; and WHEREAS, Over the years, Mr. Jelinek benefited his industry 22 23 in a number of leadership roles, among them chair and vice chair of 24
