1           WHEREAS, Gary Majors of Missouri City was appointed constable  
2 of Precinct 2 in Fort Bend County on October 25, 2016; and

3           WHEREAS, A graduate of the Houston Community College Law  
4 Enforcement Academy, Mr. Majors first joined the constable's  
5 office as a deputy in 1994; he initially worked in the warrant  
6 division but soon earned promotion to sergeant, and in that role, he  
7 oversaw the patrol officers, field training operations, and the  
8 gang resistance program; he subsequently became a lieutenant and  
9 assumed command of the education and training departments; and

10          WHEREAS, During a notable tenure that has spanned more than  
11 two decades, Constable Majors has remained committed to continuing  
12 his professional development, garnering a master peace officer  
13 license and mental health officer and civil process proficiency  
14 credentials; moreover, he is certified to teach courses on law  
15 enforcement ethics and cultural sensitivity as well as on the use of  
16 a variety of different weapons; and

17          WHEREAS, This dedicated officer of the law holds membership  
18 with such groups as the International Association of Chiefs of  
19 Police, the National Organization of Black Law Enforcement  
20 Executives, and the Justices of the Peace and Constables  
21 Association of Texas, and he has given generously of his time and  
22 talents to a number of charitable and civic organizations,  
23 including the Barbara Jordan Endeavors Corporation and the NAACP;  
24 he is also a valued member of Windsor Village United Methodist

1 Church and the Most Worshipful Prince Hall Grand Lodge of Texas,  
2 Ever Ready Lodge No. 506; and

3 WHEREAS, In all his endeavors, Mr. Majors enjoys the love and  
4 support of his wife of 12 years, Dawn, and he takes great pride in  
5 their daughter, Gabrielle; and

6 WHEREAS, Throughout his career in law enforcement, Constable  
7 Gary Majors has devoted himself to the safety and well-being of his  
8 fellow Texans, and he may indeed take pride in his outstanding  
9 record of service; now, therefore, be it

11 Legislature hereby congratulate Gary Majors on his appointment as
