1           WHEREAS, Family and friends will forever treasure their  
2 memories of Delbert Walker of Grapeland, who passed away on April  
3 24, 2017, at the age of 79; and

4           WHEREAS, Delbert Walker was born in Delhi, Louisiana, on  
5 January 16, 1938, to Henry and Ina Walker; at the age of 17, he left  
6 his family's farm and moved to Baytown; it was there that he met  
7 JoAnn Wright, whom he married in 1958; the couple shared their lives  
8 for nearly six decades, and they were blessed with two children,  
9 Keith and Rita; their family later grew to include three  
10 grandchildren, T. J. Walker, Melissa Stringer, and Stephanie Ware,  
11 and eight great-grandchildren, Colton, Emma, Brasen, Kyle, Jett,  
12 Ellie, Wesson, and Hayden; and

13           WHEREAS, Early in his working life, Mr. Walker owned a  
14 barbershop in Seabrook, where his clients included John Glenn and  
15 many of NASA's early astronauts who were training nearby;  
16 subsequently, Mr. Walker owned a successful trucking company and  
17 raised cattle on the D-J Ranch in East Texas, and after settling in  
18 Grapeland, he purchased the Grapeland Co-Op, which became the  
19 Grapeland Farm and Ranch feed store; and

20           WHEREAS, Mr. Walker was a charter member and fire chief of  
21 the fire department in Lomax, and he served on the La Porte city  
22 council; in Grapeland, he was an active member of the Lions Club and  
23 the chamber of commerce, which named him as Citizen of the Year; he  
24 was also a life member of the Houston Livestock Show and Rodeo, a

1 member of Santa Gertrudis Breeders International Herd No. 7964,  
2 and a charter member and president of the La Porte Livestock Show  
3 and Rodeo; a man of strong religious faith, he attended the Broadway  
4 Church of Christ in La Porte and the South Loop Church of Christ in  
5 Crockett; and

6 WHEREAS, A devoted family man and a dedicated civic leader,  
7 Delbert Walker lived a rich and purposeful life, and he will forever  
8 be remembered with admiration and affection by all who held him  
9 close to their hearts; now, therefore, be it

10 RESOLVED, That the House of Representatives of the 85th Texas  
11 Legislature hereby pay tribute to the memory of Delbert Walker and  
12 extend heartfelt sympathy to his relatives and many friends; and,  
13 be it further
