RESOLUTION

1 WHEREAS, The city of Houston lost an admired philanthropist 2 and businessman with the death of James Lee Ketelsen on April 27, 3 2017, at the age of 86; and WHEREAS, Born in Davenport, Iowa, on November 14, 1930, Jim 4 5 Ketelsen was the son of Ernest and Helen Ketelsen; after graduating from Northwestern University, he was commissioned as an officer in 6 7 the U.S. Navy and served aboard the USS Hunt during the Korean War; he married Joan Velde and they became the parents of a son, James, 8 9 and a daughter, Lee; following the death of Mrs. Ketelsen, he was fortunate to find love a second time with the former Kathryn Lloyd, 10 11 and they shared a fulfilling marriage that spanned 29 years; and 12 WHEREAS, Mr. Ketelsen began his career as a CPA in the Chicago office of Price Waterhouse; in 1959, he was appointed 13 14 assistant comptroller of J. I. Case Company, and he rose to become president when he was only 36 years old; after Case was acquired by 15 Tenneco, he was named CEO and chair and led the multi-industry 16 corporation until 1992; he became one of the first business 17 executives to fully recognize the importance of a healthy workforce 18 and built a state-of-the-art fitness center for employees; 19 20 moreover, he set an example of wellness as an avid runner, and he 21 initiated Tenneco's sponsorship of the Houston Marathon; and WHEREAS, Deeply committed to the community, Mr. Ketelsen 22 23 gave employees paid time off for volunteerism, and he established Project GRAD, a four-year scholarship program at Davis High School 24

1 that soon quadrupled its rate of college enrollment; following his retirement, he and his wife Kathryn built on that success by 2 3 expanding Project GRAD to improve college readiness with a set of comprehensive interventions in earlier grades; he then applied his 4 5 business acumen to the task of scaling up the initiative, and it became an influential model that was adopted across the country; 6 the Houston Independent School District paid tribute to his efforts 7 8 in 2002 by opening James L. Ketelsen Elementary School, where the children welcomed the frequent visits of their beloved "Mr. K."; 9 10 and

WHEREAS, Mr. Ketelsen benefited higher education as a regent 11 12 of the University of Houston System and a trustee of Northwestern University; he was a member of the Texas Business and Education 13 14 Coalition, the Texas Head Start Collaboration Task Force, and the 15 State Board of Education Task Force on Early Childhood and Elementary Education, and he chaired the Texas 2000 State 16 17 Coordinating Team; in addition, he helped raise funds to build the Wortham Theater, and he played a key role in the development of 18 19 Sesquicentennial Park; among numerous other leadership roles, he was a trustee of the Houston Grand Opera Association and the Texas 20 Heart Institute; he also shared his expertise as a director of such 21 firms as Sara Lee Corporation, GTE Corporation, and J. P. Morgan & 22 23 Company; and

WHEREAS, Although Jim Ketelsen's death has brought great sorrow to his loved ones, his remarkable record of civic engagement will remain a source of inspiration, and his exceptional contributions will continue to resonate for years to come; now,
