well-known clients; along the way, he became one of the early

14 promoters of paddle tennis in the United States, and he traveled the

15 world playing the sport competitively with the U.S. Padel Team; and

16 WHEREAS, This dynamic Texan was later hired as director of

17 racquet sports at the Houstonian Health Club and Spa, and in that

18 role he was able to initiate a number of charitable ventures,

19 including a diabetes fund-raiser and a mentoring program for foster

20 children; he also supported the classical music program at Rice

21 University as both a donor and fund-raiser and enjoyed attending

22 performances of the institution's opera students and its symphony

23 orchestra at venues all over the country; and

24 WHEREAS, After he was diagnosed with an aggressive form of

- 1 brain cancer in August 2013, Steve Dekker's courage, dignity, and
- 2 commitment to helping others did not waver, and throughout his
- 3 two-and-a-half-year battle, he devoted himself to advancing the
- 4 fight against cancer; he was given a seat on the MD Anderson Cancer
- 5 Center's Patient and Family Advisory Council, and he additionally
- 6 served as a strong and compassionate voice for patients on the
- 7 hospital's volunteer services and patient experience steering
- 8 committees; and
- 9 WHEREAS, Blessed with a loving family, Mr. Dekker enjoyed a
- 10 17-year relationship with Gregory Montelaro, with whom he exchanged
- 11 wedding vows in June 2015; he happily welcomed Mr. Montelaro's
- 12 children, Brett and Lauren, into his life as his own, and he was
- 13 further cherished by a wide circle of siblings, nieces, nephews,
- 14 and extended family, as well as a multitude of dear friends; his
- 15 youthful exuberance and contagious smile made an impression on
- 16 everyone he encountered, and his passion for sports and the
- 17 outdoors led him to some of his favorite pastimes, which included
