- WHEREAS, Mr. Brawner began his work in city government in
- 24 2013, when he was elected to the Katy City Council, and he was

- 2 involvement in the local community has also included service as
- 3 president of the Katy High School Band Booster Club and as vice
- 4 chair of the Houston Livestock Show and Rodeo Merchandise

- 7 love and support of Marcy Brawner, his wife of 30 years; the couple
- 8 are active members of the Parkway Fellowship Church; and
