7 Michigan; after graduating from St. Joseph High School in 1965, he
8 earned a bachelor's degree at Western Michigan University; and

10 the Berrien County Department of Human Services for 37 years, until
11 his retirement; he went on to work as chief operations officer for
12 the Four Winds Casino, and he also served as township manager for
13 St. Joseph Charter Township; and

14 WHEREAS, For many years, Mr. Fenderbosch was president of the
15 Lakeshore school board, and he also served on the board of the
16 annual Blossomtime Festival in St. Joseph and Benton Harbor;
17 moreover, he was a member of the St. Joseph/Benton Harbor Elks
18 Lodge No. 541 and Phi Sigma Epsilon fraternity as well as an
19 honorary deputy of the Berrien County Sheriff's Department; and

20 WHEREAS, A devoted family man and a leader in his community,
21 Tim Fenderbosch lived a rich and purposeful life, and he will
22 forever be a source of inspiration to all those who had the good
23 fortune to know him; now, therefore, be it
