1-17 A BILL TO BE ENTITLED
 1-18 AN ACT

1-19 relating to the production of public information available on a
 1-20 publicly accessible website.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. Sections 552.221(b-1) and (b-2), Government
 1-23 Code, are amended to read as follows:

1-24 (b-1) In addition to the methods of production described by
 1-25 Subsection (b), an officer for public information for a
 1-26 governmental body [~~political subdivision of this state~~] complies
 1-27 with Subsection (a) by referring a requestor to an exact Internet
 1-28 location or uniform resource locator (URL) address on a website
 1-29 maintained by the governmental body [~~political subdivision~~] and
 1-30 accessible to the public if the requested information is
 1-31 identifiable and readily available on that website. If the person
 1-32 requesting the information prefers a manner other than access
 1-33 through the URL, the governmental body [~~political subdivision~~] must
 1-34 supply the information in the manner required by Subsection (b).

1-35 (b-2) If an officer for public information for a
 1-36 governmental body [~~political subdivision~~] provides by e-mail an
 1-37 Internet location or uniform resource locator (URL) address as
 1-38 permitted by Subsection (b-1), the e-mail must contain a statement
 1-39 in a conspicuous font clearly indicating that the requestor may
 1-40 nonetheless access the requested information by inspection or
 1-41 duplication or by receipt through United States mail, as provided
 1-42 by Subsection (b).

1-43 SECTION 2. The changes in law made by this Act apply only to
 1-44 a request for information that is received by a governmental body or
 1-45 an officer for public information on or after the effective date of
 1-46 this Act. A request for information that was received before the
 1-47 effective date of this Act is governed by the law in effect on the
 1-48 date the request was received, and the former law is continued in
 1-49 effect for that purpose.

1-50 SECTION 3. This Act takes effect September 1, 2017.
