## A BILL TO BE ENTITLED

1	AN ACT
2	relating to a ribbon for certain members of the military forces who
3	served in support of operations to secure the Texas border.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 437.355(a), Government Code, as amended
6	by Chapters 144 (H.B. 115) and 760 (H.B. 2108), Acts of the 84th
7	Legislature, Regular Session, 2015, is reenacted and amended to
8	read as follows:
9	(a) The governor or adjutant general, if delegated the
10	authority, may adopt policies and regulations relating to awarding:
11	(1) the Texas Purple Heart Medal, which shall be
12	awarded to a service member who:
13	(A) after September 11, 2001:
14	(i) was inducted into federal service from
15	the Texas National Guard; and
16	(ii) meets the criteria for an award of the
17	federal Purple Heart Medal; or
18	(B) was wounded or killed at Fort Hood on
19	November 5, 2009;
20	(2) the Texas Superior Service Medal, which shall be

(A) a service member of the Texas military forces

(i) completed 30 or more years of honorable

- 2 (ii) continually demonstrated superior
- 3 performance and service while assigned to key leadership positions
- 4 demanding responsibility; or
- 5 (B) a civilian who has contributed significant
- 6 service to the Texas military forces;
- 7 (3) the Lone Star Distinguished Service Medal, which
- 8 shall be awarded to a member of the military forces of this state,
- 9 another state, or the United States for exceptionally outstanding
- 10 achievement or service to this state in performance of a duty of
- 11 great responsibility while serving with the Texas military forces
- 12 for whom the department receives a letter of recommendation for
- 13 award of the Lone Star Distinguished Service Medal that:
- 14 (A) gives an account of the exceptional
- 15 achievement or service; and
- 16 (B) includes facts and photographs, and extracts
- 17 from official documents to support and amplify the facts;
- 18 (4) the Texas Outstanding Service Medal, which shall
- 19 be awarded to a service member of the military forces of this state,
- 20 another state, or the United States who has performed service in a
- 21 superior and clearly outstanding manner;
- 22 (5) the Texas Humanitarian Service Medal, which shall
- 23 be awarded to a service member who:
- (A) does not meet the criteria for an award of the
- 25 federal Humanitarian Service Medal;
- 26 (B) is a member of the Texas military forces; and
- (C) while serving on state active duty or active

- 1 duty under state authority in accordance with Title 32, United
- 2 States Code, participates satisfactorily in defense support to a
- 3 mission under civilian authority to protect life or property during
- 4 or soon after a natural disaster or civil unrest in the state;
- 5 (6) the Texas Homeland Defense Service Medal, which
- 6 shall be awarded to a service member of the Texas military forces
- 7 who served:
- 8 (A) on or after September 11, 2001;
- 9 (B) on state active duty or active duty under
- 10 state authority in accordance with Title 32, United States Code;
- 11 and
- 12 (C) satisfactorily in defense support to a
- 13 mission in the state under civilian authority;
- 14 (7) the Federal Service Medal, which shall be awarded
- 15 to a service member who was inducted into federal service from the
- 16 Texas military forces between June 15, 1940, and January 1, 1946, or
- 17 after June 1, 1950, if the service was for more than 90 days;
- 18 (8) the Texas Combat Service Ribbon, which shall be
- 19 awarded to a service member of the Texas National Guard who served,
- 20 after September 11, 2001, in a hostile fire zone as designated by
- 21 the United States secretary of defense;
- 22 (9) the Texas Faithful Service Medal, which shall be
- 23 awarded to a member of the Texas military forces who has completed
- 24 five years of honorable service during which the service member has
- 25 shown fidelity to duty, efficient service, and great loyalty to
- 26 this state;
- 27 (10) the Texas Medal of Merit, which shall be awarded

- 1 to a member of the military forces of this state, another state, or
- 2 the United States who performs outstanding service or attains
- 3 extraordinary achievement in behalf of the state or United States;
- 4 (11) the Texas State Guard Service Medal, which shall
- 5 be awarded to a service member who completes three consecutive
- 6 years of honorable service in the Texas State Guard during which the
- 7 service member has shown fidelity to duty, efficient service, and
- 8 great loyalty to this state;
- 9 (12) the Texas Desert Shield/Desert Storm Campaign
- 10 Medal, which shall be awarded to a service member who was inducted
- 11 into federal service from the Texas National Guard after August 1,
- 12 1990, in support of Operation Desert Shield or Operation Desert
- 13 Storm, without regard to the place that the service member was
- 14 deployed while serving on active federal military duty;
- 15 (13) the Texas Iraqi Campaign Medal, which shall be
- 16 awarded to a service member who was inducted into federal service
- 17 from the Texas National Guard, without regard to the place that the
- 18 service member was deployed while serving on active federal
- 19 military duty, after:
- 20 (A) March 19, 2003, in support of Operation Iraqi
- 21 Freedom; or
- 22 (B) August 31, 2010, in support of Operation New
- 23 Dawn;
- 24 (14) the Texas Afghanistan Campaign Medal, which shall
- 25 be awarded to a service member who was inducted into federal service
- 26 from the Texas National Guard after October 6, 2001, in support of
- 27 Operation Enduring Freedom, without regard to the place that the

- 1 service member was deployed while serving on active federal
- 2 military duty; [and]
- 3 (15) the Cold War Medal, which, subject to Subsection
- 4 (c), shall be awarded to a member of the military forces of this
- 5 state or the United States who:
- 6 (A) served between September 2, 1945, and
- 7 December 26, 1991; and
- 8 (B) was a resident of this state at the time the
- 9 service member entered military service; and
- 10 (16) the Texas Border Security and Support Service
- 11 Ribbon, which shall be awarded to a member of the state military
- 12 <u>forces who served:</u>
- (A) on or after July 28, 2014;
- 14 (B) on state active duty; and
- (C) satisfactorily in support of operations to
- 16 <u>secure the Texas border</u>.
- 17 SECTION 2. This Act takes effect September 1, 2017.
