S.B. No. 105

A BILL TO BE ENTITLED

AN ACT

2 relating to abolishing the Pan American Games trust fund, Olympic
3 Games trust fund, Major Events reimbursement program fund, Motor
4 Sports Racing trust fund, and Events trust fund.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. (a) On September 1, 2017:

7 (1) the following are repealed:

8 (A) Chapter 1507 (S.B. 456), Acts of the 76th
9 Legislature, Regular Session, 1999 (Article [5190.14](#), Vernon's
10 Texas Civil Statutes);

11 (B) Section [335.078](#), Local Government Code; and

12 (C) Section [26.041\(j\)](#), Tax Code; and

13 (2) each fund established under Chapter 1507 (S.B.
14 456), Acts of the 76th Legislature, Regular Session, 1999 (Article
15 [5190.14](#), Vernon's Texas Civil Statutes) is abolished.

16 (b) The applicable provisions of Chapter 1507 (S.B. 456),
17 Acts of the 76th Legislature, Regular Session, 1999 (Article
18 [5190.14](#), Vernon's Texas Civil Statutes), as that chapter existed
19 immediately before the effective date of this Act, including any
20 fund established under that chapter, remain in effect as those
21 provisions apply in relation to the particular games or events
22 described by this subsection until all money from the fund for the
23 particular games or event has been disbursed and all obligations
24 under a games support contract or event support contract for the

1 particular games or event have been satisfied. This subsection
2 applies only if, before the effective date of this Act:

3 (1) pursuant to an application by a local organizing
4 committee, endorsing municipality, or endorsing county, a site
5 selection organization selects a site in this state for a
6 particular event to which Chapter 1507 applies; and

7 (2) one or more games support contracts or event
8 support contracts for the particular games or event have been
9 entered into.

10 SECTION 2. The repeal by this Act of Chapter 1507 (S.B.
11 456), Acts of the 76th Legislature, Regular Session, 1999 (Article
12 [5190.14](#), Vernon's Texas Civil Statutes), does not apply to an
13 offense committed under Chapter 1507 before September 1, 2017. An
14 offense committed before September 1, 2017, is governed by the law
15 as it existed on the date the offense was committed, and the former
16 law is continued in effect for that purpose. For purposes of this
17 section, an offense was committed before September 1, 2017, if any
18 element of the offense occurred before that date.

19 SECTION 3. This Act takes effect September 1, 2017.
