## A BILL TO BE ENTITLED

- 2 relating to the Internet broadcast of open meetings of the Texas
- 3 Racing Commission.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Article 2, Texas Racing Act (Article 179e,
- 6 Vernon's Texas Civil Statutes), is amended by adding Section 2.115
- 7 to read as follows:
- 8 Sec. 2.115. INTERNET BROADCAST AND ARCHIVE OF OPEN
- 9 MEETINGS. (a) The commission shall:
- 10 (1) broadcast over the Internet live video and audio
- 11 of each meeting of the commission that is an open meeting subject to
- 12 Chapter 551, Government Code;
- 13 (2) make a video and audio recording of reasonable
- 14 quality of the broadcast; and
- 15 (3) provide access to the archived video and audio of
- 16 the meeting on the commission's Internet website.
- 17 (b) Not later than the seventh day after the date an open
- 18 meeting of the commission is broadcast under this section, the
- 19 commission shall make available through the commission's Internet
- 20 website archived video and audio of the meeting. The commission
- 21 shall maintain the archived video and audio of the meeting on the
- 22 commission's Internet website for not less than two years after the
- 23 date the archived video and audio was first made available on the
- 24 website.

- 1 (c) The commission shall provide on the commission's
- 2 Internet website the same notice of an open meeting of the
- 3 commission that the commission is required to post under Subchapter
- 4 C, Chapter 551, Government Code. The notice must be posted on the
- 5 commission's Internet website within the time required for posting
- 6 notice under that subchapter.
- 7 (d) The commission may use for an Internet broadcast of an
- 8 open meeting of the commission under this section a room made
- 9 available to the commission on request in any state building, as
- 10 that term is defined by Section 2165.301, Government Code.
- 11 (e) The commission is exempt from the requirements of this
- 12 <u>section to the extent a catastrophe, as defined by Section</u>
- 13 <u>551.0411</u>, Government Code, or a technical breakdown prevents the
- 14 commission from complying with this section. Following the
- 15 catastrophe or technical breakdown, the commission shall make all
- 16 <u>reasonable efforts to make the required video and audio of the open</u>
- 17 meeting available in a timely manner.
- 18 (f) The commission shall consider contracting through
- 19 competitive bidding with a private individual or entity to
- 20 broadcast and archive an open meeting subject to this section to
- 21 minimize the cost of complying with this section.
- 22 SECTION 2. Section 2.115, Texas Racing Act (Article 179e,
- 23 Vernon's Texas Civil Statutes), as added by this Act, applies only
- 24 to an open meeting held on or after September 1, 2019.
- 25 SECTION 3. This Act takes effect September 1, 2017.
