1-19 relating to the applicability of adverse licensing, listing, or
 1-20 registration decisions by certain health and human services
 1-21 agencies.

1-22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-23 SECTION 1. Section 531.951(a), Government Code, is amended
 1-24 to read as follows:

1-25 (a) This subchapter applies only to the final licensing,
 1-26 listing, or registration decisions of a health and human services
 1-27 agency with respect to a person under the law authorizing the agency
 1-28 to regulate the following types of persons:

1-29 (1) a youth camp licensed under Chapter 141, Health
 1-30 and Safety Code;

1-31 (2) a home and community support services agency
 1-32 licensed under Chapter 142, Health and Safety Code;

1-33 (3) a hospital licensed under Chapter 241, Health and
 1-34 Safety Code;

1-35 (4) an institution licensed under Chapter 242, Health
 1-36 and Safety Code;

1-37 (5) an ambulatory surgical center licensed under
 1-38 Chapter 243, Health and Safety Code;

1-39 (6) a birthing center licensed under Chapter 244,
 1-40 Health and Safety Code;

1-41 (7) an abortion facility licensed under Chapter 245,
 1-42 Health and Safety Code;

1-43 (8) an assisted living facility licensed under Chapter
 1-44 247, Health and Safety Code;

1-45 (9) ~~(6)~~ a special care facility licensed under
 1-46 Chapter 248, Health and Safety Code;

1-47 (10) an end stage renal disease facility licensed
 1-48 under Chapter 251, Health and Safety Code;

1-49 (11) ~~(7)~~ an intermediate care facility licensed
 1-50 under Chapter 252, Health and Safety Code;

1-51 (12) a freestanding emergency medical care facility
 1-52 licensed under Chapter 254, Health and Safety Code;
