S.B. No. 309

A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the Palo Duro River Authority, following
- 3 recommendations of the Sunset Advisory Commission.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Sections 1, 2, 3, 5, 6, 7, 8, 9, 10, 11, and 12,
- 6 Chapter 438, Acts of the 63rd Legislature, Regular Session, 1973,
- 7 are amended to read as follows:
- 8 Sec. 1. By virtue of Section 59, Article XVI of the
- 9 Constitution of the State of Texas, there is hereby created a
- 10 conservation and reclamation district to be known as "Palo Duro
- 11 Water District," [River Authority of Texas" (hereinafter sometimes
- 12 referred to as the "Authority") which shall be a governmental
- 13 agency, a body politic and corporate, and a political subdivision
- 14 of this state.
- 15 Sec. 2. The district [Authority] hereby created and
- 16 established shall comprise all of the territory contained within
- 17 the Counties of Hansford and Moore and the City of Stinnett
- 18 [Ochiltree]. It is hereby found and determined that all of the land
- 19 thus included in the $\underline{\text{district}}$ [Authority] will be benefited by the
- 20 improvements to be acquired and constructed by the <u>district</u>
- 21 [Authority], and that the <u>district</u> [Authority] is created to serve
- 22 a public use and benefit.
- Sec. 3. The <u>district</u>, <u>inside</u> or <u>outside</u> its <u>boundaries</u>,
- 24 [Authority within its limits] is hereby empowered: (a) to develop,

1 construct or purchase dams and reservoirs. The district [Authority] is empowered to construct or to purchase all plants and 2 3 other facilities necessary or useful for the purpose of providing a source of water supply and storing, processing such water and 4 transporting and distributing it for irrigation, 5 livestock agricultural, municipal, domestic and industrial 6 raising, purposes. The district [Authority] shall at all times have power to 7 8 develop or purchase additional sources of water and to improve, enlarge and extend its water system. The district [Authority] is 9 10 also empowered to make contracts for the purchase of water; (b) in order to preserve and protect the purity of the waters of the state 11 12 and of the district [Authority] and conserve and reclaim said waters for beneficial use by the inhabitants of the district 13 14 [Authority], to provide all plants, works, facilities 15 appliances incident to or helpful or necessary to the collection, transportation, processing, disposal, and control of such waters 16 17 for agricultural, municipal, domestic, oil field flooding, mining and industrial purposes; and (c) the district [Authority] is 18 19 empowered to impound, store, control and conserve the storm and flood waters and the unappropriated flow waters [within the limits 20 of the Authority], including but not limited to the storm and flood 21 waters and unappropriated flow waters of Palo Duro Creek and Horse 22 Creek, [River and the tributaries thereof within and without its 23 24 watershed] by complying with the provisions of Chapter 1, Title 128, Revised Civil Statutes of Texas, as amended. 25

Sec. 5. No dam or other facilities for impounding water

[Texas Water Rights Commission]. 1 commission The district [Authority] is not authorized to develop or otherwise acquire 2 3 underground sources of water. The district [Authority] may sell, trade, or otherwise dispose of any real or personal property deemed 4 5 by the district [this Commission] not to be needed for district [Authority] purposes, subject to the terms of any deed of trust or 6 other indenture [issued by the Commission]. 7 8 Sec. 6. The district [Authority] is authorized to enter into contracts with cities and others for supplying water to them. 9 The <u>district</u> [Authority] is also authorized to contract with any 10 city for the rental or leasing of, or for the operation of the water 11 production, water supply, and water filtration or purification [and 12 water supply | facilities of such city upon such consideration as 13 14 the district [Authority] and the city may agree. Any such contract 15 may be upon such terms and for such time as the parties may agree, and it may provide that it shall continue in effect until bonds 16 17 specified therein and refunding bonds issued in lieu of such bonds are paid. 18 The <u>district</u> [Authority] is empowered to obtain 19 Sec. 7. 20 through appropriate hearings an appropriation permit or permits from the commission], as provided in 21 Chapter 1 of Title 128, Revised Civil Statutes of 1925, as amended. 22 23 Thereafter such permit, either upon application of the district 24 [Authority] or at the will of the commission [Texas Water Rights

Commission], may be modified by the commission [said Commission]

after an appropriate hearing to increase or decrease the amount of

water which may be appropriated $[\tau]$ and the amount which may be

- 1 stored by the <u>district</u> [Authority] to meet fluctuating demands.
- 2 On[, either upon] application by the district [Authority] or by its
- 3 own action the commission [Texas Water Rights Commission] shall
- 4 redetermine the maximum amount of water which the district
- 5 [Authority] may store in its reservoir and in making such
- 6 determination it shall consider the needs of the cities and others
- 7 that purchase water from the <u>district</u> [Authority].
- 8 Sec. 8. The <u>district</u> [Authority] is authorized to acquire
- 9 or construct within or without the boundaries of the <u>district</u>
- 10 [Authority,] a dam or dams and all works, plants and other
- 11 facilities necessary or useful for the purpose of impounding,
- 12 processing and transporting water to cities and others for
- 13 municipal, agricultural, domestic, industrial, oil field flooding,
- 14 and mining purposes. The size of the dam and reservoir shall be
- 15 determined by the \underline{board} [Board of Directors], taking into
- 16 consideration probable future increases in water requirements, and
- 17 the size of the dam shall not be limited by the amount of water
- 18 initially authorized by the commission [Texas Water Commission] to
- 19 be impounded therein. [No dam or other facilities for impounding
- 20 water shall be constructed until the plans therefor are approved by
- 21 the Texas Department of Water Resources.
- Sec. 9. The <u>district</u> [Authority] is empowered to acquire
- 23 land within or without the boundaries of the district [Authority],
- 24 and to construct, lease or otherwise acquire all works, plants and
- 25 other facilities necessary or useful for the purpose of diverting,
- 26 further impounding or storing water, processing such water and
- 27 transporting it to cities and others for agricultural, municipal,

- 1 domestic, industrial, oil field flooding, and mining purposes.
- 2 Sec. 10. (a) For the purpose of carrying out any power or
- 3 authority conferred by this Act the district [Authority] shall have
- 4 the right to acquire by condemnation in the manner provided by Title
- 5 52, Revised Statutes, as amended, relating to eminent domain:
- 6 (1) the fee simple title to land and other property and
 - easements (including land needed for the reservoir and dam and
- 8 flood easements above the probable high water line around any such
- 9 reservoirs) within the boundaries of the district [Authority]; and
- 10 (2) the fee simple title to land and other property and
- 11 easements (except for land, other property, and easements to be
- 12 used for a dam or dams or facilities for the impoundment or storage
- 13 of water) outside the boundaries of the district [Authority].
- 14 (b) The district [Authority] is hereby declared to be a
- 15 municipal corporation within the meaning of Article 3268 of said
- 16 Title 52, except that the <u>district</u> [Authority] shall not have the
- 17 right to so condemn any property which may be owned by any other
- 18 political subdivision, city or town; provided, however, that as
- 19 against persons, firms and corporations, or receivers or trustees
- 20 thereof, who have the power of eminent domain, the fee title may not
- 21 be condemned, but the <u>district</u> [Authority] may condemn only an
- 22 easement. The amount of and character of interest in land, other
- 23 property and easements thus to be acquired shall be determined by
- 24 the board [Board of Directors].

- 25 Sec. 11. The district [Authority] herein created shall be
- 26 and it is hereby empowered to control, store, conserve, protect,
- 27 distribute and utilize the storm and flood waters within the area of

- 1 the <u>district</u> [Authority] for all useful purposes permitted by law; also, to carry out flood prevention and control measures within the 2 district [Authority] and to prevent or aid in preventing damage to 3 the lands of the district [Authority] and the soil and fertility 4 5 thereof; to cooperate with all other districts, departments or agencies of the State Government, or any agency, representative, 6 instrumentality or department of the United States Government; and 7 8 to receive and accept technical and financial assistance therefrom in the accomplishment of the [said] purposes described by this 9 10 <u>section</u>. The <u>district</u> [said Authority] is further authorized and empowered to purchase, construct, maintain, or in any other lawful 11 12 manner to acquire, provide and develop all works, facilities, improvements, lands, easements and properties, which may be 13 necessary or useful in fulfilling the purposes of the district 14 15 [Authority] or any of them.
- Sec. 12. The <u>district</u> [Authority] is authorized to acquire water appropriation permits from owners of permits. The <u>district</u> [Authority] is hereby empowered to lease or acquire rights in and to storage and storage capacity in any reservoir constructed or to be constructed by any person, firm, corporation or public agency or from the United States Government or any of its agencies.
- SECTION 2. Sections 13(a), (b), (c), and (d), Chapter 438,

 Acts of the 63rd Legislature, Regular Session, 1973, are amended to

 read as follows:
- 25 (a) The <u>board</u> [Board of Directors of the Authority] shall 26 have the power to adopt and promulgate all reasonable regulations 27 to secure, maintain, and preserve the sanitary condition of all

water in and to flow into any reservoir owned by the <u>district</u>,

[Authority] to prevent waste of water or the unauthorized use
thereof, <u>and</u> to regulate residence, hunting, fishing, boating and
camping, and all recreational and business privileges, along or
around any such reservoir, [or any] body of land, or easement owned
by the district [Authority].

7 The district [Such Authority] may prescribe reasonable (b) penalties for the breach of any regulation of the <u>district</u> 8 [Authority], which penalties shall not exceed fines of more than 9 10 Two Hundred Dollars (\$200.)[, or imprisonment for not more than thirty (30) days, or may provide both such fine and such 11 The penalties hereby authorized shall be in 12 imprisonment]. addition to any other penalties provided by the laws of Texas and 13 14 may be enforced by complaints filed in the appropriate court of 15 jurisdiction, provided, however, that no rule or regulation which provides a penalty for the violation thereof shall be in effect, as 16 17 to enforcement of the penalty, until five (5) days next after the district [Authority] may have caused a substantive statement of the 18 19 particular rule or regulation and the penalty for the violation thereof to be published, once a week for two (2) consecutive weeks 20 in the county in which such reservoir is situated, or in any county 21 in which it is partly situated. The substantive statement so to be 22 published shall be as condensed as is possible to afford an 23 24 intelligent direction of the mind to the act forbidden by the rule or regulation; one (1) notice may embrace any number 25 26 regulations; there must be embraced in the notice advice that breach of the particular regulation, or regulations, will subject 27

- 1 the violator to the infliction of a penalty and there also shall be included in the notice advice that the full text of the regulations 2 3 sought to be enforced is on file in the principal office of the district [Authority], where the same may be read by any interested 4 person. Five (5) days after the second publication of the notice 5 hereby required, the advertised regulation shall be in effect, and 6 ignorance of any such regulation shall not constitute a defense to a 7 8 prosecution for the enforcement of a penalty and, the rules and regulations authorized hereby, after the required publication, 9 10 shall judicially be known to the courts and shall be considered of a nature like unto that of valid penal ordinance of a city of the 11 12 state.
- Any duly constituted peace officer, provided such 13 14 officers meet the Texas Law Officers minimum certification 15 requirements, shall have the power to make arrests when necessary to prevent or abate the commission of any offense against the 16 17 regulations of the district [Authority], and against the laws of the State of Texas, when any such offense or threatened offense 18 19 occurs upon any land, water or easement owned or controlled by the district [Authority], or to make such arrest at any place, in case 20 of an offense involving injury or detriment to any property owned or 21 controlled by such district [Authority]. 22
- (d) Territory may be annexed to the <u>district</u> [Authority], whether or not contiguous to the <u>district</u> [Authority], in the following manner:
- 26 (1) A petition praying for such annexation signed by 27 fifty (50) or a majority, whichever number is smaller, of the

1 resident, qualified voters of the territory or of duly incorporated

2 cities or towns sought to be annexed shall be filed with the board.

3 The petition shall describe the territory to be annexed by metes and

4 bounds, or otherwise, unless such territory is the same as that

5 contained within the boundaries of such city or town, in which event

6 it shall be sufficient to state that the territory to be annexed is

7 that which is contained within the boundaries of such city or town.

8 If the board [Board of Directors] finds that the petition complies with and is signed by the number of qualified 9 persons required by Subdivision (1) of this subsection, that the 10 annexation would be to the best interest of the territory, city or 11 12 town, and the district [Authority], and that the district [Authority] will be able to supply water, or cause water to be 13 14 supplied to the territory, city, or town, it shall adopt a 15 resolution stating the conditions, if any, under which such territory, city, or town may be annexed to the district 16 17 [Authority], and shall fix a time and place when and where a hearing shall be held by the board on the question of whether the territory, 18 19 city, or town sought to be annexed will be benefited by the improvements, works, and facilities then owned or operated or 20 contemplated to be owned or operated by the <u>district</u> [Authority] or 21 by the other functions of the district [Authority]. Notice of the 22 23 adoption of such resolution stating the time and place of such 24 hearing shall be published one (1) time in a newspaper of general circulation in the territory, city, or town sought to be annexed at 25 26 least ten (10) days prior to the date of such hearing. The notice shall describe the territory in the same manner in which it is 27

1 required or permitted by this Act to be described in the petition. All persons interested may appear at such hearing and offer 2 evidence for or against the proposed annexation. Such hearing may proceed in such order and under such rules as may be prescribed by 4 5 said board, and the hearing may be recessed from time to time. If, at the conclusion of the hearing, the <u>board</u> [Board of Directors] 6 finds that the property in such territory, city, or town will be 7 8 benefited by the present or contemplated improvements, works, or facilities of the district [Authority], the board [Board of 9 10 Directors | shall adopt a resolution making a finding of such benefit and calling an election in the territory, city, or town 11 12 proposed to be annexed stating therein the date of the election, the place or places of holding the same, the proposition to be voted on, 13 14 and appointing a presiding judge for each voting place who shall 15 appoint the necessary assistant judges and clerks to assist in holding the election. 16

Notice of such election shall be given by publishing a 17 substantial copy of the resolution calling the election one (1) 18 19 time in a newspaper of general circulation in the territory sought to be annexed to the $\underline{\text{district}}$ [Authority] at least ten (10) days 20 before the date set for the election. Only constitutionally 21 qualified electors who reside in the territory, city, or town 22 23 sought to be annexed shall be qualified to vote in said election. 24 Returns of the result of said election shall be made to the board. The board shall canvass the returns of the election and adopt a 25 26 resolution declaring the results thereof. If such resolution shows that a majority of the votes cast are in favor of annexation, the 27

- 1 board shall by resolution annex said territory to the <u>district</u>
- 2 [Authority], and such annexation shall thereafter be incontestable
- 3 except in the manner and within the time for contesting the
- 4 elections under the Texas Election Code, as amended.
- 5 (3) The board [Board of Directors], in calling an
- 6 election on the proposition for annexation of territory, city, or
- 7 town, may include as a part of the same proposition or a separate
- 8 proposition for the assumption of its part of the tax-supported
- 9 bonds of the <u>district</u> [Authority] then outstanding and those
- 10 theretofore voted but not yet sold, and for the levy of an ad
- 11 valorem tax on taxable property in said territory along with the tax
- 12 in the rest of the district [Authority] for the payment thereof and
- 13 the levying of maintenance taxes permitted by Section 27 of this
- 14 Act, in which event the voting shall be restricted to
- 15 constitutionally qualified electors. If such election fails, the
- 16 annexed territory, city, or town shall be excluded from the
- 17 district [Authority].
- 18 SECTION 3. Sections 14, 15, 16, 17, 18, and 19, Chapter 438,
- 19 Acts of the 63rd Legislature, Regular Session, 1973, are amended to
- 20 read as follows:
- 21 Sec. 14. The <u>district</u> [Authority] is authorized to
- 22 establish or otherwise provide for public parks and recreation
- 23 facilities, and to acquire land for such purposes within the
- 24 district [Authority].
- Sec. 15. In the event that the district [Authority], in the
- 26 exercise of the power of eminent domain or power of relocation, or
- 27 any other power granted hereunder, makes necessary the relocation,

- 1 raising, rerouting or changing the grade of, or altering the
- 2 construction of any highway, railroad, electric transmission line,
- 3 telephone or telegraph properties and facilities, or pipeline, all
- 4 such necessary relocation, raising, rerouting, changing of grade or
- 5 alteration of construction shall be accomplished at the sole
- 6 expense of the <u>district</u> [Authority].
- 7 Sec. 16. It shall not be necessary for the <u>board</u> [Board of
- 8 Directors | to call a confirmation election or to hold a hearing on
- 9 the exclusion of lands or a hearing on the adoption of a plan of
- 10 taxation, but the ad valorem plan of taxation shall be used by the
- 11 <u>district</u> [Authority].
- 12 Sec. 17. (a) All powers of the <u>district</u> [Authority] shall
- 13 be exercised by the board. Each director of the board [a Board of
- 14 Directors (sometimes herein referred to as the "Board"), each of
- 15 whom] shall serve staggered, two-year terms that expire on December
- 16 31 of each year. [for a term of two (2) years except for the
- 17 directors appointed by this Act. The following directors are hereby
- 18 appointed:

- 9 In [December of 1973 and in] December of each year, 10 [hereafter] the Commissioners Court of each county contained in the district, except for Hutchinson County, and the city council of the 11 12 City of Stinnett [Authority] shall appoint a director or directors [from such county] whose term or terms are about to expire. Any 13 vacancy shall be filled for the unexpired term by the governing body 14 15 of the appropriate county or city. Four (4) directors [members of the Board of Directors] shall be appointed by the Commissioners 16 17 Court of each county contained in the district, except for Hutchinson County, and one director shall be appointed by the city 18 council of the City of Stinnett. Each [Authority, and each] 19 20 director shall reside in the county from which the director [he] is appointed. 21
- (c) Each director shall serve for the director's [his] term
 of office as herein provided, and thereafter until the director's
 [his] successor shall be appointed and qualified. No person shall
 be appointed a director unless the person [he] resides in and owns
 taxable property in the county or city from which the person [he] is
 appointed. No member of a governing body of a county or the City of

- 1 Stinnett, and no employee of a county or the City of Stinnett shall
- 2 be appointed as director. Such directors shall subscribe the
- 3 Constitutional oath of office, and each shall give bond for the
- 4 faithful performance of the director's [his] duties in the amount
- 5 of Five Thousand Dollars (\$5,000.), the cost of which shall be paid
- 6 by the <u>district</u> [Authority]. A majority shall constitute a quorum.
- 7 If any director moves from the county or city from which the
- 8 director [he] is appointed or otherwise ceases to be a director, the
- 9 Commissioners Court of such county or the city council of the City
- 10 of Stinnett, as appropriate, shall appoint a director to succeed in
- 11 the position $[him_{\tau}]$ for the unexpired term.
- 12 (d) <u>Unless the board by resolution increases the fee to an</u>
- 13 <u>amount authorized by Section 49.060, Water Code, each</u> [<u>Each</u>]
- 14 director shall receive a fee of not to exceed Twenty-Five Dollars
- 15 (\$25.) for attending each meeting of the <u>board</u> [$ext{Board}$], provided
- 16 that no more than Fifty Dollars (\$50.) shall be paid to any director
- 17 for meetings held in any one (1) calendar month. Each director
- 18 shall also be entitled to receive not to exceed Twenty-Five Dollars
- 19 (\$25.) per day devoted to the business of the <u>district</u> [Authority]
- 20 and to reimbursement for actual expenses incurred in attending to
- 21 $\underline{\text{district}}$ [Authority] business provided that such service and
- 22 expense are expressly approved by the \underline{board} [Board].
- Sec. 18. The <u>board</u> [<u>Board of Directors</u>] shall elect from its
- 24 number a president and a vice president of the district
- 25 [Authority], and such other officers as in the judgment of the board
- 26 [Board] are necessary. The president shall be the chief executive
- 27 officer of the district [Authority] and the presiding officer of

- 1 the **board** [Board], and shall have the same right to vote as any other director. The vice president shall perform all duties and 2 3 exercise all powers conferred by this Act upon the president when the president is absent or fails or declines to act except the 4 5 president's right to vote. The board [Board] shall also appoint a secretary and a treasurer who may or may not be members of the board 6 [Board], and it may combine those offices. The treasurer shall give 7 bond in such amount as may be required by the board [Board of 8 Directors]. The condition of such bond shall be that the treasurer 9 10 [he] will faithfully account for all money which shall come into the treasurer's [his] custody as treasurer of the district [Authority], 11 12 and the board [Board] may adopt a seal for the district [Authority]. Sec. 19. The board [Board of Directors], from time to time, 13 14 shall be authorized to make or cause to be made surveys and 15 engineering investigations for the information of the <u>district</u> [Authority] to facilitate the accomplishment of the purposes for 16 17 which the district [Authority] is created; and may employ a general manager, attorneys, accountants, engineers, or other technical or 18 19 nontechnical employees or assistants; fix the amount and manner of their compensation; and may provide for the payment of expenditures 20 21 deemed essential to the proper maintenance of the <u>district</u> [Authority] and its affairs. The power to employ and discharge 22 23 employees may be conferred upon the general manager.
- 24 SECTION 4. Sections 20(a), (b), (d), (e), (f), (g), (h), and
- 25 (i), Chapter 438, Acts of the 63rd Legislature, Regular Session,
- 26 1973, are amended to read as follows:
- 27 (a) For the purpose of providing a source of water supply

1 for cities and other users for agricultural, municipal, domestic, industrial, oil field flooding, and mining purposes, as authorized 2 3 by this Act, and for the purpose of carrying out any other power or authority conferred by this Act, the district [Authority] 4 5 empowered to issue its negotiable bonds to be payable from revenues or taxes or both revenues and taxes of the <u>district</u> [Authority] as 6 are pledged by resolution of the board [Board of Directors]. 7 8 Pending the issuance of definitive bonds the board [Board] may authorize the delivery of negotiable interim bonds or notes, 9 eligible for exchange or substitution by use of the definitive 10 11 bonds.

Such bonds shall be authorized by resolution of the 12 board [Board of Directors] and shall be issued in the name of the 13 14 district [Authority], signed by the president or vice president, 15 attested by the secretary and shall bear the seal of the district [Authority]. It is provided, however, that the signatures of the 16 17 president or of the secretary or of both may be printed or lithographed on the bonds if authorized by the board [Board of 18 19 Directors], and that the seal of the <u>district</u> [Authority] may be impressed on the bonds or may be printed or lithographed thereon. 20 The bonds shall mature serially or otherwise in not to exceed forty 21 (40) years and may be sold at a price and under terms determined by 22 the board [Board of Directors] to be the most advantageous 23 24 reasonably obtainable[, provided that the interest cost to the Authority, including the discount, if any, shall bear interest at 25 any rate per annum permitted by the Constitution and laws of the 26 State as shall be determined by the Board of Directors, and within 27

- 1 the discretion of the <u>board</u> [Board] may be made callable prior to
- 2 maturity at such times and prices as may be prescribed in the
- 3 resolution authorizing the bonds, and may be made registrable as to
- 4 principal or as to both principal and interest.
- 5 The bonds may be secured by a pledge of all or part of the net revenue of the $\underline{\text{district}}$ [Authority], or by the net revenues 6 of any one (1) or more contracts theretofore or thereafter made or 7 8 other revenue or income specified by resolution of the board [Board of Directors] or in the trust indenture. Any such pledge may 9 10 reserve the right, under conditions therein specified, to issue additional bonds which will be on a parity with or subordinate to 11 the bonds then being issued. The term "net revenues" as used in 12 this Section shall mean the gross revenues and income of the 13 district [Authority] from all sources after deduction of the amount 14 15 necessary to pay the cost of maintaining and operating the district [Authority] and its properties. 16
- 17 The district [Authority] is also empowered to issue bonds payable from ad valorem taxes to be levied on all taxable 18 19 property therein, or to issue bonds secured by and payable from both such taxes and the revenues of the district [Authority]. 20 bonds are issued payable wholly or partially from ad valorem taxes, 21 it shall be the duty of the board [Board of Directors] to levy a tax 22 23 sufficient to pay the bonds and the interest thereon as such bonds 24 and interest become due without limit as to the rate or the amount, but the rate of the tax for any year may be fixed after giving 25 26 consideration to the money received from the pledged revenues which may be available for payment of principal and interest to the extent 27

- 1 and in the manner permitted by the resolution authorizing the 2 issuance of the bonds.
- 3 Where bonds payable wholly from revenues are issued, it shall be the duty of the board [Board of Directors] to fix, and from 4 5 time to time to revise, the rates of compensation for water sold and services rendered by the <u>district</u> [Authority] which will be 6 sufficient to pay the expense of operating and maintaining the 7 8 facilities of the district [Authority] and to pay the bonds as they mature and the interest as it accrues and to maintain the reserve 9 and other funds as provided in the resolution authorizing the 10 bonds. Where bonds payable partially from revenues are issued it 11 shall be the duty of the board [Board] to fix, and from time to time 12 to revise, the rate of compensation for water sold and services 13 14 rendered by the district [Authority] which will be sufficient to 15 assure compliance with the resolution authorizing the bonds.
- 16 (g) From the proceeds from the sale of the bonds, the 17 district [Authority] may set aside an amount for the payment of interest expected to accrue during construction and a reserve 18 19 interest and sinking fund, and such provision may be made in the resolution authorizing the bonds. Proceeds from the sale of the 20 bonds may also be used for the payment of all expenses necessarily 21 incurred in accomplishing the purpose for which this district 22 [Authority] is created, including expenses of issuing and selling 23 24 The proceeds from the sale of the bonds may be temporarily invested in direct obligations of the United States 25 26 Government maturing in not more than one (1) year from the date of 27 investment.

- 1 In the event of a default or a threatened default in the payment of principal or of interest on bonds payable wholly or 2 partially from revenues, any court of competent jurisdiction may, 3 upon petition of the holders of outstanding bonds, appoint a 4 5 receiver with authority to collect and receive all income of the district [Authority] except taxes, employ and discharge agents and 6 employees of the district [Authority], take charge of funds on hand 7 8 (except funds received from taxes unless commingled) and manage the proprietary affairs of the district [Attorney] without consent or 9 10 hindrance by the <u>directors</u> [Directors]. Such receiver may also be authorized to sell or make contracts for the sale of water or renew 11 12 such contracts with the approval of the court appointing him. court may vest the receiver with such other powers and duties as the 13 14 court may find necessary for the protection of the holders of the 15 bonds. The resolution authorizing the issuance of the bonds or the trust indenture securing the bonds [them] may limit or qualify the 16 17 rights of the holders of less than all of the outstanding bonds payable from the same source to institute or prosecute any 18 litigation affecting the district's [Authority's] property or 19 income. 20
- (i) Before the <u>district</u> [Authority] shall issue any bonds for improvements authorized herein, it shall secure prior approval from the <u>commission</u> [Texas Water Rights Commission] in the manner provided by Section 51.421, Texas Water Code.
- 25 SECTION 5. Sections 21 and 22, Chapter 438, Acts of the 63rd 26 Legislature, Regular Session, 1973, are amended to read as follows:
- 27 Sec. 21. The district [Authority] is authorized to issue

1 refunding bonds for the purpose of refunding any outstanding bonds authorized by this Act and interest thereon. Such refunding bonds 2 may be issued to refund more than one (1) series of outstanding 3 bonds and combine the pledges for the outstanding bonds for the 4 security of the refunding bonds, and may be secured by other or 5 additional revenues and mortgage liens. The provisions of this law 6 with reference to the issuance by the district [Authority] of other 7 8 bonds, their security, and their approval by the Attorney General and the remedies of the holders shall be applicable to refunding 9 10 bonds. Refunding bonds shall be registered by the Comptroller upon surrender and cancellation of the bonds to be refunded, but in lieu 11 12 thereof, the resolution authorizing their issuance may provide that they shall be sold and the proceeds thereof deposited in the bank 13 14 where the original bonds are payable, in which case the refunding 15 bonds may be issued in an amount sufficient to pay the principal of and the interest on the original bonds to their option date or 16 17 maturity date, and the Comptroller shall register them without concurrent surrender and cancellation of the original bonds. 18

19 Sec. 22. Any bonds (including refunding bonds) authorized by this law, not payable wholly from ad valorem taxes, may be 20 additionally secured by a trust indenture under which the Trustee 21 may be a bank having trust powers situated either within or outside 22 of the State of Texas. Such bonds, within the discretion of the 23 24 board [Board of Directors], may be additionally secured by a deed of trust or mortgage lien upon physical properties of the district 25 26 [Authority] and all franchises, easements, water rights and appropriation permits, leases and contracts and all rights 27

1 appurtenant to such properties vesting in the trustee power to sell the properties for the payment of the indebtedness, power to 2 3 operate the properties and all other powers and authority for the further security of the bonds. Such trust indenture, regardless of 4 5 the existence of the deed of trust or mortgage lien on the properties may contain any provisions prescribed by the board 6 [Board of Directors] for the security of the bonds and the 7 8 preservation of the trust estate, and may make provision for amendment or modification thereof and the issuance of bonds to 9 10 replace lost or mutilated bonds, and may condition the right to expend <u>district</u> [Authority] money or sell <u>district</u> [Authority] 11 12 property upon approval of a registered professional engineer selected as provided therein, and may make provision for the 13 14 investment of funds of the district [Authority]. Any purchaser 15 under a sale under the deed of trust lien, where one is given, shall be the absolute owner of the properties, facilities and rights so 16 purchased and shall have the right to maintain and operate the same. 17 SECTION 6. Sections 23(a), (b), and (c), Chapter 438, Acts 18 19 of the 63rd Legislature, Regular Session, 1973, are amended to read as follows: 20

21 (a) No bonds payable wholly or partially from ad valorem
22 taxes (except refunding bonds) shall be issued unless authorized by
23 a majority vote of the constitutionally qualified electors voting
24 at such election. [No territory shall be detached from the
25 Authority after the issuance of bonds which are payable from
26 revenues or taxes or both.] Bonds not payable wholly or partially
27 from ad valorem taxes may be issued without an election.

- Such election may be called by the **board** [Board of 1 Directors] without a petition. The resolution calling the election 2 3 shall specify the time and places of holding the same, the purpose for which the bonds are to be issued, the maximum amount thereof, 4 5 the maximum maturity thereof, the form of the ballot, and the presiding judge for each voting place. The presiding judge serving 6 at each voting place shall appoint one (1) assistant judge and at 7 8 least two (2) clerks to assist in holding such election. Notice of the election shall be given by publishing a substantial copy 9 10 thereof in one (1) newspaper published in each city contained in the district [Authority] for two (2) consecutive weeks. The first 11 12 publication shall be at least twenty-one (21) days prior to the election. In any city in which no newspaper is published, notice 13 shall be given by posting a copy of the resolution in three (3) 14 15 public places.
- 16 (c) The returns of the election shall be made to and canvassed by the <u>board</u> [Board of Directors of the Authority].
- SECTION 7. Sections 24, 25, 26, and 27, Chapter 438, Acts of the 63rd Legislature, Regular Session, 1973, are amended to read as follows:
- Sec. 24. After any bonds (including refunding bonds) are authorized by the <u>district</u> [Authority], such bonds and the record relating to their issuance shall be submitted to the Attorney General for [his] examination as to the validity thereof. Where such bonds recite that they are secured by a pledge of the proceeds of a contract theretofore made between the <u>district</u> [Authority] and any city or other governmental agency, authority or district, a

1 copy of such contract and the proceedings of the city or other governmental agency, authority or district authorizing such 2 contract shall also be submitted to the Attorney General. If such bonds have been authorized and if such contracts have been made in 4 5 accordance with the Constitution and laws of the State of Texas he shall approve the bonds and such contracts and the bonds then shall 6 be registered by the Comptroller of Public Accounts. Thereafter 7 8 the bonds, and the contracts, if any, shall be valid and binding and shall be incontestable for any cause. 9

10 Sec. 25. All bonds of the <u>district</u> [Authority] shall be and are hereby declared to be legal and authorized investments for 11 12 banks, savings banks, trust companies, building and association, savings and loan association, insurance companies, 13 14 fiduciaries, trustees, guardians, and for the sinking fund of 15 cities, towns, villages, counties, school districts, or other political corporations or subdivisions of the State of Texas. Such 16 17 bonds shall be eligible to secure the deposit of any and all public funds of the State of Texas, and any and all public funds of cities, 18 towns, villages, counties, school districts, or other political 19 corporations or subdivision of the State of Texas; and such bonds 20 21 shall be lawful and sufficient security for said deposits to the extent of their value, when accompanied by all unmatured coupons 22 23 appurtenant thereto.

Sec. 26. The accomplishment of the purposes stated in this
Act is for the benefit of the people of this state and for the
improvement of their properties and industries, and the <u>district</u>
[Authority], in carrying out the purposes of this Act will be

1 performing an essential public function under the Constitution.

2 The district [Authority] shall not be required to pay any tax or

3 assessment on the project or any part thereof, and the bonds issued

4 hereunder and their transfer and the income therefrom, including

5 the profits made on the sale thereof, shall at all times be free

6 from taxation within this state.

Sec. 27. The district [Authority] may upon a favorable 7 8 majority vote of the qualified property taxpaying electors of the district [Authority,] voting at an election held within the 9 10 boundaries of the district [Authority] for that purpose, levy, assess and collect annual taxes to provide funds necessary to 11 12 construct or acquire, maintain and operate dams, works, plants and facilities deemed essential or beneficial to the 13 14 [Authority] and its purposes, and also when so authorized may levy, 15 assess and collect annual taxes as provided by the Tax Code to provide funds adequate to defray the cost of the maintenance, 16 17 operation and administration of the district [Authority]; provided, however, that the district [Authority] shall not have the 18 19 power to levy or collect a tax for the maintenance, operation, and administration of the <u>district</u> [Authority] which exceeds fifty 20 21 cents (50¢) on the One Hundred Dollars (\$100) assessed valuation on the property subject to taxation. Elections for the levy of such 22 23 taxes shall be ordered by the \underline{board} [\underline{Board} of $\underline{Directors}$] and shall 24 be held and conducted in the manner provided by this law relating to elections for the authorization of bonds. The board [Board of 25 26 Directors] shall designate such polling places as they deem fitting and proper. [All taxes levied by the Authority for any purpose 27

- 1 shall constitute a lien on the property against which levied and
- 2 shall not bar the enforcement or collection thereof.
- 3 SECTION 8. Sections 28(a), (b), (d), (e), (f), and (h),
- 4 Chapter 438, Acts of the 63rd Legislature, Regular Session, 1973,
- 5 are amended to read as follows:
- 6 (a) The tax rolls of the counties situated within the
- 7 district [Authority,] are hereby adopted and shall constitute the
- 8 tax rolls of the district [Authority,] until assessment and tax
- 9 rolls shall be made by the district [Authority].
- 10 (b) If the <u>district</u> [Authority] issues and delivers bonds
- 11 which are payable wholly or partially from ad valorem taxes, or
- 12 votes the taxes as provided in Section 27 [of the Authority's Act],
- 13 the board annually shall cause the taxable property in the district
- 14 [Authority] to be rendered and assessed for ad valorem taxation,
- 15 and the value of such taxable property to be equalized, and the ad
- 16 valorem taxes in the district [Authority] to be collected, in
- 17 accordance with any of the methods set forth in this section, and
- 18 any method adopted shall remain in effect until changed by the
- 19 board.
- 20 (d) The laws of this State applicable to counties may be
- 21 adopted and shall be used to the extent pertinent and practicable,
- 22 provided that the board shall have the authority to act as its own
- 23 board of equalization or to appoint three resident, qualified
- 24 electors of the district [Authority] who own taxable property
- 25 therein to act as the board of equalization of the district
- 26 [Authority], and in either case the board of equalization shall
- 27 qualify and perform the duties prescribed by law for county

1 commissioners courts acting as boards of equalization.

- 2 The board shall be authorized to have the taxable 3 the district [Authority] assessed, equalized, and/or its taxes collected, in whole or in part, by the 4 5 tax assessors, board of equalization, and/or tax collectors, respectively, of any county, city, taxing district, or other 6 governmental subdivision in which all or any part of the district 7 8 [Authority] is located; and such property may be assessed and the values thereof equalized on the same basis or a different basis than 9 that used by any such governmental subdivision. Such property 10 shall be assessed, the values thereof equalized, and such taxes 11 collected in the manner and for such compensation as shall be agreed 12 on between the appropriate parties, and the functions thus assumed 13 14 by the officials of any such governmental subdivision shall be 15 additional duties pertaining to their offices, respectively. The ad valorem tax law applicable to each such governmental subdivision 16 17 shall apply to its officials in carrying out such functions for the district [Authority]. 18
- It is specifically provided, however, that under any 19 method used all taxable property within the district [Authority] 20 21 shall be assessed on the same basis, and the values thereof shall be equalized by only one board of equalization, in an equal and uniform 22 manner, as required by the Texas Constitution. If the board desires 23 24 that taxable property shall be assessed and taxes collected by the tax assessors and/or collectors of more than one governmental 25 subdivision, the board shall either act as its own board of 26 equalization or appoint three resident, qualified electors of the 27

- 1 <u>district</u> [Authority] who own taxable property therein to act as the
- 2 board of equalization, and in either case the board of equalization
- 3 shall qualify and perform the duties prescribed by law for county
- 4 commissioners courts acting as boards of equalization.
- 5 (h) If the district [Authority] issues and delivers bonds
- 6 payable wholly or partially from ad valorem taxes, the \underline{board}
- 7 [Board] shall levy and cause to be assessed and collected ad valorem
- 8 taxes sufficient to pay the interest on and principal of said bonds,
- 9 without limit as to the rate or the amount[, after giving
- 10 consideration to any revenues that may be pledged to the payment of
- 11 bonds].
- 12 SECTION 9. Chapter 438, Acts of the 63rd Legislature,
- 13 Regular Session, 1973, is amended by amending Section 29 and adding
- 14 Sections 1B, 13A, 19A, 19B, 19C, 19D, 19E, 19F, and 19G to read as
- 15 follows:
- Sec. 29. (a) The board [Board of Directors] shall designate
- 17 one (1) or more banks within the district [Authority] to serve as
- 18 depository for the funds of the district [Authority]. All funds of
- 19 the district [Authority] shall be deposited in such depository bank
- 20 or banks except that funds pledged to pay bonds may be deposited
- 21 with the trustee bank named in the trust agreement, and except that
- 22 funds shall be remitted to the bank of payment for the payment of
- 23 principal of and interest on bonds. To the extent that funds in the
- 24 depository banks and the trustee bank are not insured by the
- 25 F.D.I.C. they shall be secured in the manner provided by law for the

The term of service 4 5 for depositories shall be prescribed by the board [Board]. notice shall be published one (1) time in a newspaper or newspapers 6 published in the district [Authority] and specified by the board 7 8 [Board].
- 9 At the time mentioned in the notice, the board [Board] 10 shall consider the applications and the management and condition of the banks filing them, and shall designate as depositories the bank 11 or banks which offer the most favorable terms and conditions for the 12 handling of the funds of the district [Authority] and which the 13 board [Board] finds have proper management and are in condition to 14 15 warrant handling of <u>district</u> [Authority] funds. Membership on the board [Board of Directors] of an officer or director of a bank shall 16 17 not disqualify such bank from being designated as depository.
- (d) If no applications are received by the time stated in the notice, the <u>board</u> [Board] shall designate some bank or banks within or without <u>the district</u> [Authority] upon such terms and conditions as it may find advantageous to the <u>district</u> [Authority].
- Sec. 1B. In this Act:
- 23 (1) "Board" means the district's board of directors.
- 24 (2) "Commission" means the Texas Commission on
- 25 Environmental Quality.
- 26 (3) "Director" means a member of the board.
- 27 (4) "District" means the Palo Duro Water District.

- 1 Sec. 13A. (a) A county or municipality may withdraw from
- 2 the district or the district may dissolve according to this
- 3 section.
- 4 (b) In order to withdraw from the district or to dissolve
- 5 the district, the governing body of a county or municipality that is
- 6 a member of the district must issue an order or pass a resolution
- 7 declaring the intent to withdraw from or dissolve the district. The
- 8 order or resolution must state:
- 9 (1) the intention to either withdraw from the district
- 10 or call for the dissolution of the district; and
- 11 (2) the reasons supporting the withdrawal or
- 12 dissolution.
- 13 (c) Not later than the 30th day after the date the district
- 14 receives an order or resolution under Subsection (b), the district
- 15 shall hold a public hearing on the matter described by the order or
- 16 <u>resolution</u>.
- 17 (d) In the event of a proposed withdrawal or dissolution
- 18 under this section, the member counties and municipality must reach
- 19 a financial agreement that:
- 20 (1) for a withdrawal of a county or municipality from
- 21 the district, provides for sufficient revenue for maintaining the
- 22 Palo Duro Reservoir and the dam that impounds the water in the
- 23 <u>reservoir; or</u>
- 24 (2) for a dissolution of the district, provides for
- 25 the transfer of:
- 26 (A) the ownership rights of the dam to an entity
- 27 that assumes responsibility for the maintenance of the dam and

- 1 liability for actions related to the dam;
- 2 (B) all assets and liabilities of the district to
- 3 other entities; and
- 4 (C) the responsibility for the continued
- 5 provision of services, if the district provides services.
- 6 (e) The board must provide an opportunity for the public to
- 7 comment on the financial agreement described by Subsection (d)
- 8 before the board votes as described by Subsection (f). The period
- 9 for public comment must last not less than 10 days.
- 10 (f) After consideration of the public comments submitted
- 11 under Subsection (e), the board shall vote on the issue described by
- 12 the order or resolution under Subsection (b). The board may proceed
- 13 with the withdrawal or dissolution only if two-thirds of all of the
- 14 members of the board vote in favor of withdrawal or dissolution.
- 15 (g) If the board votes in favor of withdrawal or dissolution

- 1 that provide the public with a reasonable opportunity to appear
- 2 before the board and to speak on any agenda item at board meetings.
- 3 Sec. 19B. A director who has a financial interest in a
- 4 contract under consideration by the district for the purchase,
- 5 sale, lease, rental, or supply of property, including supplies,
- 6 materials, and equipment, or the construction of facilities, shall
- 7 disclose that fact to the other members of the board and may not
- 8 vote on or participate in discussions during board meetings on the
- 9 acceptance of the contract. A financial interest of a director does
- 10 not affect the validity of a contract if disclosure is made and the
- 11 director with the financial interest does not vote on the question
- 12 of entering into the contract.
- 13 Sec. 19C. Not earlier than the 10th day after the date a
- 14 director receives written notice of a charge against the director,

- 17 charge described by the notice, the board may remove a director for:
- 18 (1) inefficiency;
- 19 (2) neglect of duty; or
- 20 (3) misconduct in office.
- Sec. 19D. (a) A person who is appointed to and qualifies
- 22 for office as a director may not vote, deliberate, or be counted as
- 23 <u>a director in attendance at a meeting of the board until the person</u>
- 24 completes a training program that complies with this section.
- (b) The training program must provide the person with
- 26 information regarding:
- 27 <u>(1) the law governing district operations;</u>

- 1 (2) the programs, functions, rules, and budget of the
- 2 district;
- 3 (3) the scope of and limitations on the rulemaking
- 4 authority of the district;
- 5 (4) the results of the most recent formal audit of the
- 6 district;
- 7 (5) the requirements of:
- 8 (A) laws relating to open meetings, public
- 9 information, administrative procedure, and disclosing conflicts of
- 10 interest; and
- 11 (B) other laws applicable to members of the
- 12 governing body of a water district in performing their duties; and
- 13 (6) any applicable ethics policies adopted by the
- 14 board or the Texas Ethics Commission.
- 15 (c) A person appointed to the board is entitled to
- 16 reimbursement for the travel expenses incurred in attending the
- 17 training program regardless of whether the attendance at the
- 18 program occurs before or after the person qualifies for office.
- 19 (d) The board shall create a training manual that includes
- 20 the information required by Subsection (b). The board shall
- 21 distribute a copy of the training manual annually to each director.
- 22 On receipt of the training manual, each director shall sign a
- 23 statement acknowledging receipt of the training manual.
- Sec. 19E. The board shall develop and implement policies
- 25 that clearly separate the policymaking responsibilities of the
- 26 board and the management responsibilities of the general manager
- 27 and staff of the district.

- 1 Sec. 19F. (a) The district shall maintain a system to
- 2 promptly and efficiently act on complaints filed with the district.
- 3 The district shall maintain information about parties to the
- 4 complaint, the subject matter of the complaint, a summary of the
- 5 results of the review or investigation of the complaint, and its
- 6 disposition.
- 7 (b) The district shall make information available
- 8 describing its procedures for complaint investigation and
- 9 resolution.
- 10 <u>(c) The district shall periodically notify the complaint</u>
- 11 parties of the status of the complaint until final disposition.
- 12 Sec. 19G. (a) The district shall develop a policy to
- 13 encourage the use of:
- 14 (1) negotiated rulemaking procedures under Chapter
- 15 2008, Government Code, for the adoption of district rules; and
- 16 (2) appropriate alternative dispute resolution
- 17 procedures under Chapter 2009, Government Code, to assist in the
- 18 resolution of internal and external disputes under the district's
- 19 jurisdiction.
- 20 (b) The district's procedures relating to alternative
- 21 dispute resolution must conform, to the extent possible, to any
- 22 model guidelines issued by the State Office of Administrative
- 23 Hearings for the use of alternative dispute resolution by state
- 24 agencies.
- 25 (c) The district shall:
- 26 (1) coordinate the implementation of the policy
- 27 adopted under Subsection (a);
