14	(b) Notice provided under Subsection (a) must:
15	(1) appear in a conspicuous place in the renewal
16	<pre>notice;</pre>
17	(2) clearly indicate each change to the policy being
18	<pre>made on renewal;</pre>
19	(3) be written in plain language; and
20	(4) be provided to the insured not later than the 30th
21	day before the renewal date.
22	(c) If an insurer elects to change a policy form on renewal,
23	not later than the 30th day before the earliest renewal date on
24	which the new policy form is used, the insurer shall provide written

1 notice to each agent of the insurer that clearly indicates each 2 change being made to the policy.

3 SECTION 2. Section 2002.001, Insurance Code, is amended to 4 read as follows:

5 Sec. 2002.001. ENDORSEMENTS REDUCING AMOUNT OF COVERAGE. 6 <u>(a)</u> An insurer may not use an endorsement to a policy form to which 7 Article 5.35, Subchapter B <u>of this chapter</u>, or Subchapter B, 8 Chapter 2301, applies that reduces coverage that would otherwise be 9 provided under the policy unless:

the insured requests the endorsement; or

11 (2) the insurer provides the policyholder <u>in a written</u>
12 <u>notice an</u> [with a written] explanation of [the change made by] the
13 endorsement <u>that:</u>

14 (A) appears in a conspicuous place on the notice 15 of the endorsement; 16 (B) clearly indicates each change to the policy

17 made by the endorsement;

18 (C) is written in plain language; and

(D) is provided to the insured not later than the
 30th day before the date on which the policy expires.

(b) Notice required by Subsection (a) may be provided to the
 insured in a renewal notice.

23 (c) If an insurer elects to use an endorsement described by
24 Subsection (a), not later than the 30th day before the earliest date
25 on which the endorsement is used, the insurer shall provide written
26 notice to each agent of the insurer that clearly indicates each
27 change made to the policy form by the endorsement.

1 <u>clearly indicates each change being made to the policy.</u>

2 <u>(d)</u> The commissioner may adopt rules as necessary to 3 implement this section.

SECTION 5. The change in law made by this Act applies only to an insurance policy delivered, issued for delivery, or renewed on or after January 1, 2018. A policy delivered, issued for delivery, or renewed before that date is governed by the law as it existed immediately before the effective date of this Act, and that law is continued in effect for that purpose.

SECTION 6. This Act takes effect September 1, 2017.
