## A BILL TO BE ENTITLED

1	AN ACT
2	relating to a prohibition of the land application of grit or grease
3	trap waste.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter C, Chapter 361, Health and Safety
6	Code, is amended by adding Section 361.1215 to read as follows:
7	Sec. 361.1215. LAND APPLICATION OF GRIT AND GREASE TRAP
8	WASTE PROHIBITED. (a) In this section:
9	(1) "Grease trap waste" means a material collected in
10	and from a grease interceptor in the sanitary sewer line of a
11	commercial, institutional, or industrial food service or
12	processing facility. The term includes the solids resulting from a
13	dewatering process.
14	(2) "Grit trap" means a unit or chamber that:
15	(A) allows the sedimentation of solids from an
16	influent liquid stream by reducing the flow velocity of the stream;
17	(B) has an inlet and outlet that are both located
18	at the same vertical level at or near the top of the unit or chamber;
19	(C) has an outlet that is connected to a sanitary
20	sewer system; and
21	(D) is not designed to separate oil and water.
22	(3) "Grit trap waste" means the waste collected in a
23	grit trap. The term includes waste from an interceptor placed in a
24	drain at maintenance and repair shops, automobile service stations,

- 1 car washes, laundries, and other similar facilities.
- 2 (b) The commission may not issue a permit, registration, or
- 3 other authorization for land application of grit trap waste or
- 4 grease trap waste.
- 5 (c) This section does not apply to a permit, registration,
- 6 or other authorization issued to an entity for the disposal of
- 7 grease trap waste or grit trap waste at a municipal solid waste Type
- 8 I landfill, a municipal solid waste Type V facility, or a compost
- 9 facility.
- 10 SECTION 2. A permit, registration, or other authorization
- 11 issued by the Texas Commission on Environmental Quality that allows
- 12 the land application of grease trap waste or grit trap waste expires
- 13 on the effective date of this Act. The remainder of a permit,
- 14 registration, or other authorization that contains items in
- 15 addition to an authorization allowing the land application of
- 16 grease trap waste or grit trap waste remains in effect to the extent
- 17 that it does not authorize the land application of grease trap waste
- 18 or grit trap waste.
- 19 SECTION 3. This Act takes effect immediately if it receives
- 20 a vote of two-thirds of all the members elected to each house, as
- 21 provided by Section 39, Article III, Texas Constitution. If this
- 22 Act does not receive the vote necessary for immediate effect, this
- 23 Act takes effect September 1, 2017.
