(a) In this section: 9 (1) "Program attendee" means a child enrolled in a 10 11 full-day or half-day before-school or after-school program. 12 (2) "Screen time" means time spent viewing television or videos or working on computers, tablets, and handheld 13 14 entertainment devices, with or without Internet access. (b) The department shall develop a voluntary program for 15 16 recognizing licensed before-school and after-school programs that promote healthy eating and physical activity. 17 18 (c) The department shall assess a before-school or 19 after-school program applying for recognition under this section based on the program's compliance with the following requirements: 20 21 (1) at least one staff member of the before-school or after-school program is trained on the standards of this section 22 23 and the importance of modeling healthy eating and physical activity 24 in the presence of program attendees;

No. 757 (2) the before-school or after-school program 1 provides opportunities for program attendees to participate in at 2 least 30 minutes of moderate to vigorous physical activity for a 3 half-day program and at least 60 minutes of moderate to vigorous 4 5 physical activity for a full-day program; 6 (3) the before-school or after-school program limits 7 screen time during the operational hours of the program to less than 8 30 minutes a day for a half-day program and two hours a day for a full-day program, not including use in connection with homework or 9 10 an activity that engages program attendees in a physical activity or educational experience; 11 12 (4) the before-school or after-school program: (A) makes healthy foods, including fruits and 13 14 vegetables that are fresh, frozen, dried, or canned in their own 15 juice or water, without added sugar, available to program attendees 16 during meals or snacks; and 17 (B) encourages program attendees and staff while in the presence of program attendees during the operational hours 18 19 of the program to not eat fried foods or foods that are primarily sugar-based, are high in calories or sodium, or include trans fat; 20 21 (5) the before-school or after-school program complies with the following guidelines relating to the serving and 22 23 consumption of beverages: 24 (A) program attendees are served water, low-fat 25 or nonfat milk, nonfat flavored milk, or 100 percent fruit juice; 26 (B) safe, clean drinking water is available and accessible at all times to program attendees and staff; and 27

No. 757 1 (C) beverages with added sugar are not served to program attendees or consumed by staff in the presence of program 2 3 attendees during the operational hours of the program; and 4 (6) the before-school or after-school program engages 5 parents, guardians, and caregivers of program attendees using informational materials and activities focused on healthy eating 6 7 and physical activity relevant to the health of program attendees 8 at least four times each year. 9 (d) The staff training described by Subsection (c)(1) must comply with the requirements of the National Institute on 10 Out-of-School Time, the Healthy Out-of-School Time Coalition, or 11 12 other similar programs. The training may be completed in person or 13 online. 14 (e) The department shall establish the following levels of recognition for before-school and after-school programs applying 15 for recognition under this section: 16 17 (1) bronze status for a before-school or after-school program that: 18 19 (A) meets the staff training requirements provided by Subsection (c)(1); and 20 21 (B) complies with at least one other requirement listed in <u>Subsection (c);</u> 22 23 silver status for a before-school or after-school (2) 24 program that: (A) meets the staff training requirements 25 26 provided by Subsection (c)(1); and 27 (B) complies with at least three other

2	(3) gold status for a before-school or after-school
3	program that:
4	(A) meets the staff training requirements
5	provided by Subsection (c)(1); and
6	(B) complies with at least four other
7	requirements listed in Subsection (c).
8	(f) The department, as it determines appropriate, may
9	provide technical assistance to before-school and after-school
10	programs seeking to advance to a higher recognition level under
11	Subsection (e).
12	(g) A before-school or after-school program that meets the
13	requirements for a recognition level provided by Subsection (e) may
14	create a corresponding recognition certificate using a certificate
15	template created by the department. A recognition certificate
16	expires on December 31 of each odd-numbered year. A program may
17	renew a recognition certificate if the program applies for renewal
18	not later than January 1 of the year after the date a recognition
19	certificate expires.
20	(h) The department shall post information about the
21	recognition program on the department's Internet website,
22	including:
23	(1) resources and links that a before-school or
24	after-school program may use to meet the requirements of Subsection
25	<u>(c); and</u>
26	(2) a template that a before-school or after-school
27	program may use to create a certificate, signed by the director of

1	the before-school or after-school program, that describes the
2	program's recognition level.
3	(i) The department shall maintain a list of each
4	before-school or after-school program that qualifies for
5	recognition under this section and shall post the list on the
6	department's Internet website. The list must include the program's
7	recognition level and the date the program's recognition
8	certificate expires.
9	(j) The requirements of this section are in addition to any
10	other requirement imposed by law that applies to a before-school or
11	after-school program.
12	(k) The executive commissioner may adopt rules to implement
13	this section.
14	SECTION 2. This Act takes effect January 1, 2018.
