1-19 A BILL TO BE ENTITLED 1-20 AN ACT

1-21 relating to an exemption from licensing requirements for physicians 1-22 associated with certain sports teams.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter B, Chapter 151, Occupations Code, is amended by adding Section 151.0521 to read as follows:

Sec. 151.0521. EXEMPTION FOR SPORTS TEAM PHYSICIAN. A person is exempt from the licensing requirements of this subtitle and may engage in the practice of medicine in this state if the person:

(1)is employed or designated as a team physician by a sports team visiting this state for a specific sporting event;
(2) is licensed to practice medicine in the team's home

state; and

(3)limits the person's practice of medicine in this state to treating, during the period beginning on the date the team arrives in this state for the event and ending on the 10th day after the date of the event:

(A) the members, coaches, and staff of the team;
