5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter A, Chapter 28, Education Code, is
7	amended by adding Section 28.020 to read as follows:
8	Sec. 28.020. MATHEMATICS INNOVATION ZONES. (a) The
9	commissioner may:
10	(1) on application of a school district or
11	open-enrollment charter school, designate a campus of the district
12	or school as a mathematics innovation zone; and
13	(2) from funds appropriated or donated for purposes of
14	this section, award a grant to support implementation of innovative
15	mathematics instruction at the campus in accordance with this
16	section.
17	(b) A campus designated as a mathematics innovation zone
18	<pre>must:</pre>
19	(1) implement with fidelity an innovative mathematics
20	instructional program approved by the commissioner for purposes of
21	this section that addresses the essential knowledge and skills of
22	the mathematics curriculum required by Section 28.002;

- 2 (3) provide all data relating to the mathematics
- 3 innovation zone requested by the agency.
- 4 (c) A campus designated as a mathematics innovation zone is
- 5 not subject to interventions under the state accountability system
- 6 described by Section 39.107(a) or (e) for the first two years of the
- 7 designation, provided that the campus implements the instructional
- 8 program with fidelity and complies with each mathematics innovation
- 9 zone requirement to the satisfaction of the commissioner. The
- 10 period that a campus is exempt from interventions as provided by
- 11 this subsection is not:
- 12 (1) included in calculating consecutive school years
- 13 under Section 39.107(a) or (e); or
- 14 (2) considered a break in consecutive school years of
- 15 unacceptable ratings for purposes of determining the need for
- 16 intervention under Section 39.107(a) or (e).
- 17 (d) The commissioner may revoke designation of a campus as a
- 18 mathematics innovation zone and suspend associated grant funding if
- 19 the commissioner determines that the campus has failed to implement
- 20 the instructional program with fidelity or comply with any
- 21 requirement imposed under this section.
- 22 <u>(e) A school district or open-enrollment charter school may</u>
- 23 use a pay for success program approved by the commissioner under
- 24 Section 44.904 to pay costs associated with designation of a campus
- 25 as a mathematics innovation zone.
- 26 (f) The commissioner may accept gifts, grants, or donations
- 27 from any public or private source for purposes of this section.

(g) The commissioner may adopt rules as necessary to 1 2 administer this section. (h) A decision or determination by the commissioner under 3 4 this section is final and may not be appealed. SECTION 2. Subchapter Z, Chapter 44, Education Code, is 5 6 amended by adding Section 44.904 to read as follows: Sec. 44.904. PAY FOR SUCCESS PROGRAMS. (a) In this 7 section, "pay for success program" means a program involving 8 private financing under which payments are dependent on achievement 9 10 of measurable outcomes. (b) The commissioner may: 11 12 (1) structure and approve pay for success programs for use by a school district or open-enrollment charter school; 13 14 (2) evaluate and approve the following participants in 15 a pay for success program: 16 (A) a private investor; 17 (B) an education service provider; and (C) a third-party evaluator; and 18 19 (3) require an approved participant to comply with the objectives, metrics, and other pay for success program requirements 20 prescribed by the commissioner. 21 22 (c) In evaluating a potential participant under Subsection (b)(2), the commissioner may: 23

- 3 (d) Notwithstanding any other law, a school district or
- 4 open-enrollment charter school that uses a pay for success program
- 5 approved by the commissioner is not subject to state procurement
- 6 requirements that would otherwise apply to the activity funded
- 7 through the program.
- 8 <u>(e) The commissioner, the agency, and agency employees are</u>
- 9 immune from liability for actions associated with the structuring,
- 10 approval, or implementation of a pay for success program.
- 11 (f) The commissioner may adopt rules as necessary to
- 12 implement this section.
- SECTION 3. This Act takes effect September 1, 2017.
