A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the possession of a child on the child's birthday under
- 3 a standard possession order in a suit affecting the parent-child
- 4 relationship.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 153.314, Family Code, is amended to read
- 7 as follows:
- 8 Sec. 153.314. HOLIDAY POSSESSION UNAFFECTED BY DISTANCE
- 9 PARENTS RESIDE APART. The following provisions govern possession
- 10 of the child for certain specific holidays and supersede
- 11 conflicting weekend or Thursday periods of possession without
- 12 regard to the distance the parents reside apart. The possessory
- 13 conservator and the managing conservator shall have rights of
- 14 possession of the child as follows:
- 15 (1) the possessory conservator shall have possession
- 16 of the child in even-numbered years beginning at 6 p.m. on the day
- 17 the child is dismissed from school for the Christmas school
- 18 vacation and ending at noon on December 28, and the managing
- 19 conservator shall have possession for the same period in
- 20 odd-numbered years;
- 21 (2) the possessory conservator shall have possession
- 22 of the child in odd-numbered years beginning at noon on December 28
- 23 and ending at 6 p.m. on the day before school resumes after that
- 24 vacation, and the managing conservator shall have possession for

- 1 the same period in even-numbered years;
- 2 (3) the possessory conservator shall have possession
- 3 of the child in odd-numbered years, beginning at 6 p.m. on the day
- 4 the child is dismissed from school before Thanksqiving and ending
- 5 at 6 p.m. on the following Sunday, and the managing conservator
- 6 shall have possession for the same period in even-numbered years;
- 7 (4) <u>if a [the]</u> parent <u>is</u> not otherwise entitled under
- 8 this standard possession order to <u>any period of</u> [present]
- 9 possession of a child on the child's birthday, that parent shall
- 10 have possession of the child beginning at 6 p.m. and ending at 8
- 11 p.m. on that day, provided that the parent picks up the child from
- 12 [the residence of the conservator entitled to possession] and
- 13 returns the child to $\underline{\text{the residence of the conservator entitled to}}$
- 14 possession [that same place];
- 15 (5) if a conservator, the father shall have possession
- 16 of the child beginning at 6 p.m. on the Friday preceding Father's
- 17 Day and ending on Father's Day at 6 p.m., provided that, if he is not
- 18 otherwise entitled under this standard possession order to present
- 19 possession of the child, he picks up the child from the residence of
- 20 the conservator entitled to possession and returns the child to
- 21 that same place; and
- 22 (6) if a conservator, the mother shall have possession
- 23 of the child beginning at 6 p.m. on the Friday preceding Mother's
- 24 Day and ending on Mother's Day at 6 p.m., provided that, if she is
- 25 not otherwise entitled under this standard possession order to
- 26 present possession of the child, she picks up the child from the
- 27 residence of the conservator entitled to possession and returns the

- 1 child to that same place.
- 2 SECTION 2. The change in law made by this Act to Section
- 3 153.314, Family Code, applies only to a court order providing for
- 4 possession of or access to a child rendered on or after the
- 5 effective date of this Act. A court order rendered before the
- 6 effective date of this Act is governed by the law in effect on the
- 7 date the order was rendered, and the former law is continued in
- 8 effect for that purpose.
- 9 SECTION 3. This Act takes effect September 1, 2017.
