## A BILL TO BE ENTITLED

AN ACT

2 Relating to making supplemental appropriations and giving

direction and adjustment authority regarding appropriations.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. APPROPRIATION REDUCTION: PUBLIC FINANCE

AUTHORITY. The unencumbered appropriations from the general

7 revenue fund to the Public Finance Authority made by Chapter 1281

8 (H.B. 1), Acts of the 84th Legislature, Regular Session, 2015 (the

9 General Appropriations Act), for use during the state fiscal

10 biennium ending August 31, 2017, for bond debt service payments,

11 including appropriations subject to Rider 2, page I-47, Chapter

12 1281 (H.B. 1), Acts of the 84th Legislature, Regular Session, 2015

13 (the General Appropriations Act) to the bill pattern of the

14 appropriations to the authority, are reduced by a total aggregate

15 of \$39,856,983. The Public Finance Authority shall identify the

16 strategies and objectives to which the reduction is to be allocated

17 and the amount of the reduction for each of those strategies and

18 objectives.

19 SECTION 2. DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES:

20 ADDITIONAL APPROPRIATIONS. In addition to amounts previously

21 appropriated for the state fiscal biennium ending August 31, 2017,

22 the following amounts are appropriated from the general revenue

23 fund to the Department of Family and Protective Services for the

- 10 SECTION 3. DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES:
- 11 CERTAIN TRANSFERS. Notwithstanding the limitations of Rider 32,
- 12 page II-43, Chapter 1281 (H.B. 1), Acts of the 84th Legislature,
- 13 Regular Session, 2015 (the General Appropriations Act), to the bill
- 14 pattern of the appropriations to the Department of Family and
- 15 Protective Services, the department shall transfer \$435,475 from
- 16 Strategy B.1.11., Relative Caregiver Payments, to Strategy B.1.9.,

- 23 biennium ending August 31, 2017, \$5,100,000 is appropriated from

- 25 state fiscal year ending August 31, 2017, for the purpose of paying
- 26 for, or reimbursing payments made for, costs incurred by the forest
- 27 service associated with responding to various weather-related

- 2 SECTION 5. ANIMAL HEALTH COMMISSON: CATTLE FEVER TICKS. In
- 3 addition to amounts previously appropriated for the state fiscal
- 4 biennium ending August 31, 2017, the Animal Health Commission is
- 5 appropriated \$649,987 out of the general revenue fund for the
- 6 preparedness, response and mitigation for cattle fever ticks under
- 7 Strategy A.1.1., Field Operations as listed in Chapter 1281 (H.B.
- 8 1), Acts of the 84th Legislature, Regular Session, 2015 (the
- 9 General Appropriations Act).
