4	SECTION 1. Section 3503.003(a), Special District Local Laws
5	Code, is amended to read as follows:
6	(a) The authority is created to:

- 4 (F) flood control, water, wastewater treatment,

- 7 (G) other infrastructure improvements; and
- 8 (H) any other services or facilities acquired by
- 9 the authority from the United States;
- 10 (4) promote or support an active military base located
- 11 in the same county as the authority to prevent closure or

- 14 (5) exercise the powers granted to a conservation and

- 19 SECTION 2. Subchapter C, Chapter 3503, Special District
- 20 Local Laws Code, is amended by adding Section 3503.112 to read as
- 21 follows:
- Sec. 3503.112. NONPROFIT CORPORATIONS FOR SPECIAL
- 23 PROJECTS. (a) The authority may authorize by resolution the
- 24 creation of a nonprofit corporation under the Business
- 25 Organizations Code solely to undertake on behalf of the authority a
- 26 project described by Section 3503.003(a)(3).
- 27 (b) The board shall appoint the board of directors of each

- 1 nonprofit corporation created under this section. A board member
- 2 <u>is not required to reside in the authority.</u>
- 3 (c) A board member or employee of the authority may
- 4 <u>simultaneously serve as a member of the board of directors of a</u>
- 5 nonprofit corporation. A person serving as a board member of the
- 6 authority and of a nonprofit corporation created by the authority
- 7 may participate in all votes relating to the business of the
- 8 authority or the corporation, regardless of any statutory
- 9 prohibition.
- 10 SECTION 3. This Act takes effect September 1, 2017.
