1 AN ACT relating to mental health first aid training for university 2 3 employees. Δ BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 1001.201, Health and Safety Code, is 5 amended by adding Subdivision (6) to read as follows: 6 7 (6) "University employee" means a person employed by a public or private institution of higher education who regularly 8 interacts with students enrolled at the university through the 9 10 course of the person's duties. SECTION 2. The heading to Section 1001.203, Health and 11 12 Safety Code, is amended to read as follows: 13 Sec. 1001.203. GRANTS FOR TRAINING CERTAIN UNIVERSITY EMPLOYEES, SCHOOL DISTRICT EMPLOYEES, AND SCHOOL RESOURCE OFFICERS 14 [EDUCATORS] IN MENTAL HEALTH FIRST AID. 15 SECTION 3. Sections 1001.203(a), (c), and (e), Health and 16 Safety Code, are amended to read as follows: 17 (a) To the extent funds are appropriated to the department 18 for that purpose, the department shall make grants to local mental 19 health authorities to provide an approved mental health first aid 20 training program, administered by mental health first aid trainers, 21 at no cost to university employees, school district employees, and 22 school resource officers. 23 24 (c) The department shall grant \$100 to a local mental health

1 authority for each <u>university employee</u>, school district employee, 2 or school resource officer who successfully completes a mental 3 health first aid training program provided by the authority under 4 this section.

(e) A local mental health authority may contract with a
regional education service center to provide a mental health first
aid training program to <u>university employees</u>, <u>school district</u>
<u>employees</u>, <u>and school resource officers</u> [<u>educators</u>] under this
section.

SECTION 4. The heading to Section 1001.2031, Health and Safety Code, is amended to read as follows:

Sec. 1001.2031. SUPPLEMENTAL GRANTS FOR TRAINING CERTAIN
 <u>UNIVERSITY EMPLOYEES, SCHOOL DISTRICT EMPLOYEES, AND SCHOOL</u>
 RESOURCE OFFICERS [EDUCATORS] IN MENTAL HEALTH FIRST AID.

15 SECTION 5. Section 1001.205, Health and Safety Code, is 16 amended to read as follows:

17 Sec. 1001.205. REPORTS. (a) Not later than September 30 18 of each year, a local mental health authority shall provide to the 19 department the number of:

(1) employees and contractors of the authority who were trained as mental health first aid trainers under Section 1001.202 during the preceding fiscal year;

(2) <u>university employees</u> [educators], school district
 employees [other than educators], and school resource officers who
 completed a mental health first aid training program offered by the
 authority under Section 1001.203 during the preceding fiscal year;

(3) individuals who are not <u>university employees</u>,
 school district employees, or school resource officers who
 completed a mental health first aid training program offered by the
 authority during the preceding fiscal year.

5 (b) Not later than December 1 of each year, the department 6 shall compile the information submitted by local mental health 7 authorities as required by Subsection (a) and submit a report to the 8 legislature containing the number of:

9 (1) authority employees and contractors trained as 10 mental health first aid trainers during the preceding fiscal year;

11 (2) <u>university employees</u> [educators], school district 12 employees [other than educators], and school resource officers who 13 completed a mental health first aid training program provided by an 14 authority during the preceding fiscal year; and

(3) individuals who are not <u>university employees</u>,
school district employees, or school resource officers who
completed a mental health first aid training program provided by an
authority during the preceding fiscal year.

19 SECTION 6. This Act takes effect immediately if it receives 20 a vote of two-thirds of all the members elected to each house, as 21 provided by Section 39, Article III, Texas Constitution. If this 22 Act does not receive the vote necessary for immediate effect, this 23 Act takes effect September 1, 2017.
