- 4 SECTION 3. Sections 375.064(a), (b), and (c), Local
- 5 Government Code, are amended to read as follows:

- 7 shall, and the owners of a majority of the assessed value of
- 8 property subject to assessment by the district may, recommend to
- 9 the governing body of the municipality persons to serve on the
- 10 succeeding board.
- 11 (b) After reviewing the recommendations, the governing body
- 12 shall approve or disapprove the directors recommended under

- 14 (c) If the governing body is not satisfied with the

- 13 [(2) 75 percent or more of the surface area of the

- 25 otherwise, of a corporate owner of property in the district;
- 26 (3) an owner of a beneficial interest in a trust that

- 1 (4) an agent, employee, or tenant of a person covered
- 2 by Subdivision (1), (2), or (3) [meet the qualifications of Section
- 3 375.063].
- 4 SECTION 9. Section 3855.052(b), Special District Local Laws
- 5 Code, is amended to read as follows:
- 6 (b) Section 375.063(2) [375.063(3)], Local Government Code,
- 7 does not apply to the district.
- 8 SECTION 10. The change in law made by this Act to Section
- 9 375.063, Local Government Code, does not affect the entitlement of
- 10 a member serving on the board of directors of a district to which
- 11 that section applies immediately before the effective date of this
- 12 Act to continue to carry out the board's functions for the remainder
- 13 of the member's term. The change in law applies only to a member
- 14 appointed on or after the effective date of this Act.
- 15 SECTION 11. This Act takes effect September 1, 2017.
