A BILL TO BE ENTITLED

1	AN ACT
2	relating to authorizing the purchase of certain insurance coverage
3	by public school districts for the benefit of businesses and
4	students participating in career or technology training programs
5	and providing for immunity from liability of certain public school

7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
8	SECTION 1. Subchapter F, Chapter 29, Education Code, is
9	amended by adding Sections 29.191 and 29.192 to read as follows:
10	Sec. 29.191. HEALTH BENEFIT PLAN, LIABILITY, AND AUTOMOBILE
11	INSURANCE COVERAGE. (a) The board of trustees of a school district
12	may obtain health benefit plan, liability, or automobile insurance
13	<pre>coverage to protect:</pre>
14	(1) a business or entity that partners with the
15	district to provide district students a career and technology
16	training program; and
17	(2) a district student who participates in a district
18	career and technology training program.
19	(b) The coverage authorized by this section must be:
20	(1) obtained from a reliable insurer authorized to
21	engage in business in this state; or
22	(2) provided through a self-funded risk pool.
23	(c) The amount of coverage the district obtains must be
24	reasonable considering the financial condition of the school

- 1 district and may not exceed the amount that, in the opinion of the
- 2 board of trustees, is reasonably necessary.
- 3 (d) If the board of trustees obtains health benefit plan,
- 4 liability, or automobile insurance coverage under this section, the
- 5 board shall notify the parent or guardian of each student
- 6 participating in the career and technology training program.
- 7 (e) The failure of any board of trustees to obtain coverage
- 8 authorized by this section may not be construed as placing any legal
- 9 liability on the school district or the district's officers,
- 10 agents, or employees for any injury that results.
- 11 Sec. 29.192. IMMUNITY FROM LIABILITY. A student who
- 12 participates in a career and technology training program sponsored
- 13 by a school district is entitled to immunity in the same manner as a
- 14 professional employee of a school district under Subchapter B,
- 15 <u>Chapter 22.</u>
- SECTION 2. Section 29.187(f), Education Code, is repealed.
- SECTION 3. This Act applies beginning with the 2017-2018
- 18 school year.
- 19 SECTION 4. This Act takes effect immediately if it receives
- 20 a vote of two-thirds of all the members elected to each house, as
- 21 provided by Section 39, Article III, Texas Constitution. If this
- 22 Act does not receive the vote necessary for immediate effect, this
- 23 Act takes effect September 1, 2017.
