- 2 relating to the set aside, collection, and transfer of certain
- 3 money for the Texas Racing Commission.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 6.091(a), Texas Racing Act (Article
- 6 179e, Vernon's Texas Civil Statutes), is amended to read as
- 7 follows:
- 8 (a) An association shall distribute from the total amount
- 9 deducted as provided by Section 6.08(a) and 6.09(a) of this Act from
- 10 each simulcast pari-mutuel pool and each simulcast cross-species
- 11 pool the following shares:
- 12 (1) an amount equal to one percent of each simulcast
- 13 pool to the commission to fund the agency's activities [as the
- 14 amount set aside for the state];
- 15 (2) an amount equal to 1.25 percent of each simulcast
- 16 cross-species pool to the commission to fund the agency's
- 17 activities [as the amount set aside for the state];
- 18 (3) if the association is a horse racing association,
- 19 an amount equal to one percent of a multiple two wagering pool or
- 20 multiple three wagering pool as the amount set aside for the
- 21 Texas-bred program to be used as provided by Section 6.08(f) of this
- 22 Act;
- 23 (4) if the association is a greyhound association, an
- 24 amount equal to one percent of a multiple two wagering pool or a

- 1 multiple three wagering pool as the amount set aside for the
- 2 Texas-bred program for greyhound races, to be distributed and used
- 3 in accordance with rules of the commission adopted to promote
- 4 greyhound breeding in this state; and
- 5 (5) the remainder as the amount set aside for purses,
- 6 expenses, the sending association, and the receiving location
- 7 pursuant to a contract approved by the commission between the
- 8 sending association and the receiving location.
- 9 SECTION 2. Section 6.091(b), Texas Racing Act (Article
- 10 179e, Vernon's Texas Civil Statutes), is repealed.
- 11 SECTION 3. (a) The changes in law made by this Act to
- 12 Section 6.091, Texas Racing Act (Article 179e, Vernon's Texas Civil
- 13 Statutes), apply to the deduction from a pari-mutuel pool for a race
- 14 conducted by a racetrack association on or after the effective date
- 15 of this Act.
- 16 (b) As soon as practicable after the effective date of this
- 17 Act, the Texas Racing Commission shall revise existing rules or
- 18 adopt new rules as necessary to comply with Section 6.091, Texas
- 19 Racing Act (Article 179e), Vernon's Texas Civil Statutes), as
- 20 amended by this Act.
- 21 SECTION 4. This Act takes effect September 1, 2017.
