3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Subtitle G, Title 8, Insurance Code, is amended
5	by adding Chapter 1510 to read as follows:
6	CHAPTER 1510. TEMPORARY HEALTH INSURANCE RISK POOL
7	Sec. 1510.001. DEFINITION. In this chapter, "pool" means a
8	temporary health insurance risk pool that is established and
9	administered by the commissioner under this chapter.
10	Sec. 1510.002. ESTABLISHMENT OF TEMPORARY HEALTH INSURANCE
11	RISK POOL. To the extent that federal funds become available under
12	federal law, regulation, or executive action after March 1, 2017,
13	the commissioner may:
14	(1) apply for such funds; and
15	(2) use such funds to establish and administer a
16	temporary health insurance risk pool for the purposes of this
17	chapter.
18	Sec. 1510.003. PURPOSE OF POOL. (a) The exclusive purpose
19	of the pool is to provide a temporary mechanism for maximizing
20	available federal funding to assist residents of this state in

- 3 Sec. 1510.004. PROVISION OF COVERAGE. Subject to any
- 4 requirements for obtaining federal funds held in the pool, the
- 5 commissioner may use pool funds:
- 6 (1) to provide alternative individual health
- 7 <u>insurance coverage to eligible individuals that does not diminish</u>
- 8 the availability of traditional commercial health care coverage;
- 9 (2) to provide funding to individual health benefit
- 10 plan issuers that cover individuals with certain health or cost
- 11 characteristics in exchange for lower enrollee premium rates; or
- 12 (3) to provide a reinsurance program for health
- 13 benefit plan issuers in the individual market in exchange for lower
- 14 enrollee premium rates.
- Sec. 1510.005. CONTRACTS AND AGREEMENTS. (a) The
- 16 commissioner may enter into a contract or agreement that the
- 17 commissioner determines is appropriate to carry out this chapter,
- 18 including a contract or agreement with:
- 19 (1) a similar pool in another state for the joint
- 20 performance of common administrative functions;
- 21 (2) another organization for the performance of
- 22 <u>administrative functions; or</u>
- 23 (3) a federal agency.
- 24 (b) The commissioner may contract for stop-loss insurance
- 25 for risks incurred under this chapter.
- Sec. 1510.006. FUNDING. (a) The commissioner may use funds
- 27 appropriated to the department to:

- 1 (1) apply for federal funding and grants; and
- 2 (2) administer this chapter.
- 3 (b) Notwithstanding Section 6(e)(2)(B), Chapter 615 (S.B.
- 4 1367), Acts of the 83rd Legislature, Regular Session, 2013, the
- 5 commissioner may use money appropriated to the department from the
- 6 healthy Texas small employer premium stabilization fund for the
- 7 <u>exclusive purposes of this chapter, other than for paying salaries</u>
- 8 and salary related benefits.
- 9 (c) Notwithstanding Section 6(e)(2)(B), Chapter 615 (S.B.
- 10 1367), Acts of the 83rd Legislature, Regular Session, 2013, the
- 11 commissioner shall transfer money from the healthy Texas small
- 12 employer premium stabilization fund to the Texas Department of
- 13 Insurance operating account in an amount equal to the amount of
- 14 money appropriated to the department from that fund, as described
- 15 by Subsection (b), for the direct and indirect costs of the
- 16 <u>exclusive purposes of this chapter.</u>
- 17 (d) Except as provided by Subsections (a) and (b), the
- 18 commissioner may not use any state funds to fund the pool unless the
- 19 funds are specifically appropriated for that purpose.
- 20 (e) The commissioner may use federal funds to administer
- 21 this chapter, as appropriate.
- Sec. 1510.007. PUBLIC EDUCATION AND OUTREACH. (a) The
- 23 commissioner may use funds appropriated to the department for the
- 24 exclusive purposes of this chapter to develop and implement public
- 25 <u>education</u>, outreach, and facilitated enrollment strategies under
- 26 this chapter.
- 27 (b) The commissioner may contract with marketing

- 1 organizations to perform or provide assistance with the strategies
- 2 described by Subsection (a).
- 3 Sec. 1510.008. WAIVER. (a) The commissioner may apply to
- 4 the United States secretary of health and human services under 42
- 5 U.S.C. Section 18052 for a waiver of applicable provisions of the
- 6 Patient Protection and Affordable Care Act (Pub. L. No. 111-148)
- 7 and any applicable regulations or guidance with respect to health
- 8 insurance coverage in this state for a plan year beginning on or
- 9 after January 1, 2017.
- 10 (b) The commissioner may take any action the commissioner
- 11 considers appropriate to make an application under this section.
- 12 (c) The commissioner may implement a state plan that meets
- 13 the requirements of a waiver granted in response to an application
- 14 under Subsection (a) if the plan is:
- 15 (1) consistent with state and federal law; and
- (2) approved by the United States secretary of health
- 17 and human services.
- 18 Sec. 1510.009. ADDITIONAL AUTHORITY. In addition to the
- 19 powers granted to the commissioner under this chapter, the
- 20 commissioner may exercise any authority that may be exercised under
- 21 the law of this state by:
- (1) a reinsurer; or
- 23 (2) a health benefit plan issuer authorized to write
- 24 health benefit plans in this state.
- Sec. 1510.010. RULES. The commissioner may adopt rules
- 26 necessary to implement this chapter, including rules to administer
- 27 the pool and distribute money from the pool.

1 Sec. 1510.011. EXEMPTION FROM STATE TAXES AND FEES. 2 Notwithstanding any other law, a program created under this chapter is not subject to any state tax, regulatory fee, or surcharge, 3 including a premium or maintenance tax or fee. 4 Sec. 1510.012. ANNUAL REPORT OF POOL ACTIVITIES. 5 (a) Beginning June 1, 2018, not later than June 1 of each year, the 6 7 department shall submit a report to the governor, the lieutenant 8 governor, and the speaker of the house of representatives. 9 (b) The report submitted under Subsection (a) must: (1) summarize the activities conducted under this 10 chapter in the calendar year preceding the year in which the report 11 12 is submitted; and (2) include information relating to: 13 14 (A) net written and earned premiums; 15 (B) plan enrollment; 16 (C) administration expenses; and 17 (D) paid and incurred losses. Sec. 1510.013. EXPIRATION OF CHAPTER. This chapter expires 18 19 August 31, 2019. SECTION 2. Notwithstanding Section 6(d)(2), Chapter 615 20 21 (S.B. 1367), Acts of the 83rd Legislature, Regular Session, 2013, 22 on the effective date of this Act, the commissioner of insurance shall transfer any money remaining outside the state treasury in 23 24 the Texas Treasury Safekeeping Trust Company account established

under Section 6(c), Chapter 615 (S.B. 1367), Acts of the 83rd

Legislature, Regular Session, 2013, to the healthy Texas small

employer premium stabilization fund.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this

5 Act takes effect September 1, 2017.
