- Sec. 2.101. POLITICAL SUBDIVISION BOND OR TAX ELECTION. An election held by a political subdivision to authorize the issuance of bonds or a tax increase has no effect regarding the issuance of the bonds or the tax increase unless more than 25 percent of the registered voters of the political subdivision vote in the election in which the bond or tax proposition is on the ballot.
- SECTION 3. Section 85.062, Election Code, is amended by
- 18 adding Subsection (h) to read as follows:
- (h) In an election held by a political subdivision for whichthe ballot includes a proposition seeking voter approval of the
- 21 issuance of bonds or a tax increase, a temporary branch polling
- 21 <u>issuance of bonds of a tax increase, a temporary branch politing</u>

- 23 (1) remain at the same location for the entire period
- 24 during which early voting by personal appearance is conducted in

- 5 SECTION 4. Chapter 271, Election Code, is amended by adding

- 7 Sec. 271.015. JOINT ELECTIONS REQUIRED FOR POLITICAL
- 8 SUBDIVISION BOND OR TAX INCREASE APPROVAL. (a) Notwithstanding

- 11 election under this chapter.

- SECTION 5. Section 1251.001, Government Code, is amended to

- 22 to be paid from ad valorem taxes] unless the issuance is first

- 24 [county or municipality] in an election.

- 6 (A) three public places in the political
- 7 <u>subdivision</u> [county or municipality] holding the election; and
- 8 (B) the county courthouse of any county in which
- 9 the political subdivision is located, if the election is held by a
- 10 political subdivision other than a municipality [a county
- 11 election], or the city hall, if the election is a municipal
- 12 election; and
- 13 (2) publishing notice of the election in a newspaper
- 14 of general circulation published in the political subdivision
- 15 [county or municipality] holding the election.
- SECTION 7. Section 1251.004, Government Code, is amended to
- 17 read as follows:
- 18 Sec. 1251.004. IMPOSITION OF TAX. At an election ordered on
- 19 the issuance of bonds of a [county or municipality, or of a]
- 20 political subdivision or a defined district of a county or
- 21 municipality payable from ad valorem taxes, the governing body of
- 22 the political subdivision [county or municipality] shall also
- 23 submit the question of whether to impose a tax on property in the
- 24 [county, municipality,] political subdivision[τ] or defined
- 25 district to pay interest on the bonds and to provide a sinking fund
- 26 to redeem the bonds.
- 27 SECTION 8. Section 1251.006, Government Code, is repealed.

- SECTION 9. The changes in law made by this Act apply only to bonds authorized to be issued or a tax increase authorized on or after the effective date of this Act. Bonds or a tax increase authorized before the effective date of this Act are governed by the law in effect when the bonds were authorized, and the former law is continued in effect for that purpose.
- SECTION 10. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution.

 If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2017.
