(a) All governmental and proprietary actions of the LaSalle Municipal Utility District No. 2 taken before the 18 effective date of this Act, including the creation of the district, 19 the consent to create the district granted by the City of San 20 Marcos, the consent agreement relating to the district and any 21 amendments to that agreement, and any extension of time in which to 22 hold a confirmation election for the district, are validated, 23 24 ratified, and confirmed in all respects.

(b) This section does not apply to any matter that on the effective date of this Act:

27 (1) is involved in litigation if the litigation

S.B. No. 2296 1 ultimately results in the matter being held invalid by a final court 2 judgment; or

(2) has been held invalid by a final court judgment. 3 4 SECTION 5. (a) The legal notice of the intention to 5 introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a 6 copy of this Act have been furnished to all persons, agencies, 7 8 officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, 9 10 Government Code.

(b) The governor, one of the required recipients, has submitted the notice and Act to the Texas Commission on Environmental Quality.

14 (c) The Texas Commission on Environmental Quality has filed 15 its recommendations relating to this Act with the governor, the governor, 16 lieutenant and the speaker of the house of representatives within the required time. 17

18 (d) All requirements of the constitution and laws of this 19 state and the rules and procedures of the legislature with respect 20 to the notice, introduction, and passage of this Act are fulfilled 21 and accomplished.

SECTION 6. For purposes of Section 8473.052(b)(2), Special District Local Laws Code, as amended by this Act, the effective date of the temporary directors' designation is the effective date of this Act.

26 SECTION 7. This Act takes effect immediately if it receives 27 a vote of two-thirds of all the members elected to each house, as

provided by Section 39, Article III, Texas Constitution. If this
Act does not receive the vote necessary for immediate effect, this
Act takes effect September 1, 2017.
