About 40% of the doctors in the Dallas area trained at Parkland.










#### **Payor Mix**







#### **Uncompensated Care**

In fiscal year 2016, Parkland provided approximately \$871.4 million in uncompensated care.



While Parkland is the safety-net provider for our county's indigent population, most of our patients are working Dallas residents who simply do not have access to health care.





- In FY '15 Parkland had close to 58,000 patient visits from individuals who were not Dallas County residents.
- While some were emergency and unavoidable, many indigent individuals seek care at Parkland.
- One of Parkland's goals is to ensure we are good stewards of Dallas County taxpayers' dollars. Parkland has limited financial and workforce resources and is unable to treat all indigent patients who live outside the county.
- Total unfunded out-of-county care for FY'15 was over \$24 million.
- Treating patients who are not eligible for care at Parkland restricts access for those patients who are entitled by law to our services.
