
Why an Article V Convention is bad for Texas

Balanced Budget Amendment

How will Texas cut 30% of her budget (federal funds) to achieve a federally balanced budget?

Texas already has an application for the Balanced Budget Amendment; along with 25 other states (New Mexico rescinded theirs last week -2/16/17)....

<u>1977</u> - HCR 31, 65th R.S - BALANCED BUDGET AMENDMENT—but ONLY in the ABSENCE of A NATIONAL EMERGENCY - all federal appropriations shall not exceed all estimated federal revenues. (DOES NOT PROHIBIT THE RAISING OF TAXES) Two years later, the U.S. was put under a national emergency and we've been that way ever since.

HB 506 (Phil King) and the engrossed SB 21 (Birdwell) **Delegate Selection to an Article V convention**

Proposing to set guidelines for selection of Texas' delegates; <u>if Congress doesn't issue instructions</u> , then Half of delegates will be from each chamber (House & Senate), or if the total number be odd, 3/5 from the
House and 2/5 from the Senate
□ "UNauthorized Vote – "A vote determined to be an unauthorized vote is invalid." Article V Oversight Committee (SB21) to determine whether a vote cast by a delegate or alternate delegate is an unauthorized
vote (after the vote is cast). How will a vote be rescinded? Criminal Penalty (SB21) of "state jail felony"; a county judge may reduce the sentence to 10 days in a
county jail, hardly worth the cost to prosecute.
Delegates can vote to make the proceedings secret – that's what they did on May 29, 1787 at the federal "amendments" convention where our present Constitution was drafted.
If the proceedings are secret, the States won't know what is going on - and can't stop it.
And if Delegates vote by secret ballot – the States would NEVER know who did what, making it impossible for States to prosecute Delegates who ignore State instructions.
All this is why James Madison, Alexander Hamilton, and Supreme Court Justices Arthur J. Goldberg, Warren Burger, and Antonin Scalia warned AGAINST an Article V convention.
Don't fall for this scam. The idea is to deceive you into believing that an Article V convention is safe and Delegates can be controlled. It isn't and they can't.
Delegate Immunities
U.S. Constitution Article I, Section 6. <u>The Senators and Representatives</u> shall receive a compensation for their services, to be ascertained by law, and paid out of the treasury of the United States. They <u>shall in all cases</u> , <u>except treason</u> , <u>felony and breach of the peace</u> , <u>be privileged from arrest during their attendance at the session of their respective Houses</u> , and in going to and returning from the same; and for any speech or debate in either House, they shall not be questioned in any other place.
TEXAS Constitution Article 3. LEGISLATIVE DEPARTMENT Sec. 14. PRIVILEGED FROM ARREST. <u>Senators and Representatives shall, except in cases of treason, felony, or breach of the peace, be privileged from arrest during the session of the Legislature, and in going to and returning from the same.</u>
□ The U.S. Senate passed Federal Convention Act of 1973 on July 9, 1973. "SEC. 7. (c) Delegates shall <u>in all cases, except treason, felony, and breach of the peace, be privileged from arrest during their attendance at a session of the convention, and in going to and returning from the same and for any speech or debate in the convention they shall not be questioned in any other place." [also see 2014 CRS report, titled "The Article V Convention to Propose Constitutional Amendments: Contemporary Issues for Congress", page 37] https://tinyurl.com/mdgqbtq</u>
An Article V convention will convene under the U.S. Constitution, not the State Constitutions. Delegates from

all states will be vested with plenipotentiary powers. Texas will have no power over delegates once a

convention convenes.

Texas Should Have Confidence in Joining Other States

This year, nine states have killed their Article V convention applications...

1. Arkansas 6. Utah

2. Kansas3. * Montana8. Washington

4. New Mexico (rescinded BBA application) 9. Wyoming

5. South Dakota

Delaware (May 2016) Rescinded ALL outstanding applications for an Article V convention.

* MONTANA: House Rep Brad Tschida killed his own COSP bill in the House Judiciary Committee on February 16, 2017, after realizing the Constitution isn't broken, therefore Article V is not the solution.

Article VI is the solution!
