NOTICE OF INTENT TO INTRODUCE A BILL

Pursuant to the Constitution and laws of the State of Texas, notice is hereby given of the intention to apply to the 85th Legislature of the State of Texas at its regular session in Austin, Texas for the introduction of a bill, the substance of the contemplated law being as follows: An act relating to the creation of the Blaketree Municipal Utility District No. 2 of Montgomery County; providing authority to impose a tax and issue bonds.

The Act proposes to create a conservation and reclamation district to be known as Blaketree Municipal Utility District No. 2 of Montgomery County, being one tract of land equaling approximately 452.0 acres in Montgomery County, Texas, more particularly described as follows:

Located southwest of the intersection of Moon Camp Road and Farm to Market Highway 1486; north of and adjacent to Blaketree Municipal Utility District No. 1 of Montgomery County; bounded on the north by Moon Camp Road; and bounded on the east by Farm to Market Highway 1486.

The District's creation is subject to approval at a confirmation election.




