

Pursuant to the Constitution and laws of the State of Texas, notice is hereby given of the intention to apply to the 85th Legislature of the State of Texas at its regular session in Austin, Texas, for the introduction of a bill, the substance of the contemplated law being as follows:

An act relating to the creation, administration, powers, duties, operation, and financing of the Harris County Municipal Utility District No. 553.

The Act proposes to create a municipal utility district to be known as the Harris County Municipal Utility District No. 553, located on the northwest corner of Cumberland Ridge Road and the Grand Parkway (Texas Highway No. 99), being approximately 276 acres in Harris County and within the extra-territorial jurisdiction of the City of Houston, Texas, subject to approval at a confirmation election.

All interested persons will, therefore, take notice of the matters and facts set out in the foregoing statement of the substance of the contemplated laws as required by the Constitution and laws of the State of Texas.
