Pursuant to the Constitution and laws of the State of Texas, notice is hereby given of the intention to apply to the 85th Legislature of the State of Texas at its regular

session in Austin, Texas for the introduction of a bill, the substance of the contemplated law being as follows:

An act relating to the creation of the Driftwood Municipal Utility District No. 1 of Hays County; providing authority to impose a tax and issue bonds.

The Act proposes to create a conservation and reclamation district to be known as Driftwood Municipal Utility District No. 1 of Hays County, Texas, more particularly described as follows: Approximately 358 acres of land in Hays County, Texas, generally located on the east side of Ranch to Market Road 150, approximately 2.3 miles south of the intersection of Ranch to Market Road 150 and Ranch to Market Road 1826.


